Convention Proceedings.

THURSDAY MORNING.

JULY 25TH, 1891.

Pursuant to adjournment the Women's Baptist State Convention met with the Second Baptist Church of Eufaula, Ala. Mrs. Brooks, the President, being absent, Mrs. Bowie, Vice-President, called the meeting to order at 12 M.

Rev. J. H. Eason of Selma, Ala., led the devotional exercises. He read first Corinthians, II chapter, after which the Convention sang hymn 227 in Select Gems. Prayer by Rev. Eason. The Pesident then asked all to join in the general prayer and experience meeting. After singing Rev. I. T. Simpson led in prayer. Mrs. Bowie then gave a short account of her experience since last meeting.

Rev. J. Q. A. Wilhite then read a few verses of scripture that he felt would express his feelings, and led in

prayer.

Then Miss Knapp, of Birmingham, made a few remarks, and offered prayer, which very touchingly told her joy at being able to be with the Convention. Brother Grant then requested the following hymn to be sung, "Jesus I my cross have taken," saying that it would express his feelings better than words. Then followed prayers by Mrs. M. M. Owens and Mrs. L. Byrd. Mrs. Nickerson very feelingly expressed her joy at being able to be present at another meeting of the Convention.

The delegates being tired and dusty, some having just arrived, it was best to adjourn, to meet again. So it was motioned to adjourn to meet at three o'clock. Before

After prayer by Rev. W. H. McAlpine, D. D., adjourned to meet at three o'clock.

THURSDAY AFTERNOON.

Pursuant to adjournment the Convention re-assembled promptly at three o'clock, Mrs. Bowie in the chair.

After singing hymn 65 in Select Gems, prayer by Mrs.

England of Birmingham.

Then followed a few remarks from Sister Uunderwood; Rev. D. T. Gulley, who gave us some practical thoughts as to enlarging the work; Mrs. Wright, and Mrs. Mathews.

A paper was then read by Mrs. Owens of Mobile. Subject: "Some Plans for Raising Money." She gave quite an excellent paper, with many practical thoughts. The paper was well discussed, the following taking part:

Mrs. Byrd opened the discussion, Miss Knapp, Mrs.

England.

Dr. Manaway was then introduced to the Convention; he spoke then on the paper; among other things said, that doing was better than saying, at the same time giving fifty cents, and asking the others to do the same.

A collection was then taken of \$5.45, Mrs. Bowie called Mrs. Owens to the chair, while she took the collection.

Rev. J. Q. A. Wilhite then spoke, followed by Rev. D. T. Gulley. Rev. Eason rising to speak, was asked to come forward, and was introduced to the Convention, after which he spoke to the paper. Mrs. Bowie. Miss Knapp and Rev. C. L. Fisher then spoke. The time for discussing having ended, it was moved and seconded, that the discussion be closed, carried. Some discussion arising as to whether it was right to have the welcome address before the permanent organization had been effected, a motion was made that the welcome address would be given at seven o'clock. Carried.

The following committees were then appointed:

It was moved and seconded to adjourn. Carried.

After prayer by Rev. J. M. Mason the convention adourned to meet at seven o'clock.

THURSDAY NIGHT.

Pursuant to adjournment the convention met at eight o'clock. It being past time, and Rev. J. P. Barton not having arrived, devotional exercises were conducted by the President, Mrs. Bowie.

After singing, Rev. J. H. Eason led in prayer,

Then the convention sang, "Savior more than life to me." Prayer by Rev. D. T. Gulley."

Then sang, "'Tis the promise of God." Prayer by Rev. O. Bryant.

The choir then gave some excellent music, after which Miss Leonard of Enfaula gave the welcome address, which was responded to by Mrs. England of Birmingham.

Rev. Dr. McAlpine was then introduced by Rev. J. Q. A. Wilhite, and preached the introductory sermon from Mark, XVI—3. "Who shall roll us away the stone from the door of the sepulcher?" The sermon was full of words of encouragement, cheering the hearts of the sisters, and filling them with new zeal to do more, and to stop at no difficulties. It was a grand sermon, and was enjoyed by all the convention.

After the sermon, Rev. J. M. Mason of Tuscaloosa led in prayer. The choir gave some music, and a collection of \$8.58 was taken up.

The programme for the morning meeting was then read. Sister Gairy having just arrived, and being tired, asked that sister Stokes be asked to lead the morning prayer meeting in her stead. Sister Stokes was appointed to lead the prayer meeting.

The convention then adjourned to meet Friday morning at nine o'clock.

FRIDAY MORNING.

JULY 26TH 1891.

After prayer meeting, which was led by Mrs. Stokes of Demopolis, the President called the meeting to order for business. Rev. J. T. Simpson conducting the devotional exercises. He read Psalm CIII.

Rev. W. H. McAlpine then offered prayer.

The President then made a few remarks, asking the convention to keep good order, and to pay strict, attention to business.

The minutes of the previous session were then read. It was moved and seconded that the minutes be received, Carried.

Mrs. Owens was then called to the chair.

Mrs. Bowie moved that the paper by Mrs. M. M. Owens of Mobile, (on Thursday) be published in full in the "Student's Voice," and the "Baptist Leader," and that a synopsis of it appear in the minutes. After some discussion by Mrs. Tyler, Revs. J. Q. A. Wilhite, D. T. Gulley, J. H. Hason and Brother R. Grant, the motion was carried.

The committee on permanent organization not being ready to report, Miss Europe's paper was then called for.

Subject—"The needs of the work, and how to meet them." The paper was a grand one; and presented just such thoughts as was needed before the convention. Discussion was opened by Mrs. Tyler, who said that whenever Selma University was the subject of discussion, that her heart welled up with so much love, that words failed to express her feelings. She was followed by Mesdames Gairy, Merrill, Eliza Callen and Pitts. A collection of thirty two dollars, (\$32.00) was then taken.

Brother Grant gave another dollar. He had already become an annual member.

We have carefully considered the matter; all the officers have been faithful in the discharge of their duties, but as all should help bear the burdens, we have made some changes. We recommend for President, Mrs. A. A. Bowie, Birmingham; Vice-President, Mrs. A. Tyler, Lowndesboro; Recording Secretary, S. H. Wright, Montgomery; Corresponding Secretary, Miss A. Europe, Mobile; Treasurer, Mrs. E. W. Pollard, Selma. For Executive Board, we recommend the

same with the addition of Mrs. M. M. Owens name in place of Mrs. Pollard, Mrs. Pollard being recommended for Treasurer.

Mrs. Collins moved that the report coming from the committee be received and adopted. Seconded by Misse Knapp.

Mrs. Miller then asked Mrs. M. M. Owens to conduct the new President to the chair and introduce her to the convention. Mrs. Bowie, in a few well chosen remarks, thanked the convention for the honor conferred, promising, so far as able, to faithfully perform her duty.

The next paper by request being appointed for night. Miss H. Curtis being absent, Miss Tyler was asked to open the discussion on the paper entitled "Impressions." Mrs. Tyler begged to be excused. Mrs. Knapp was then called upon, followed by Rev. C. L. Fisher.

No one else caring to speak, the next paper was called for—Miss Eliza Walker, of Talladega. Subjuct: "How to arouse an interest in the work." Mrs. Nickerson was appointed to prepare some thoughts to open the paper for discussion.

Miss Knapp's paper was then called for, but on account of physical weakness she had not prepared her paper. She however, consented to open the discussion. Her subject was "God's approval of women's work." Mrs. England and Miss Europe taking part in the discussion. Then followed the reading of letters, after which an intermission of twellty minutes was taken.

On reasonabling sang "Oh how I love Jesus." Prayer by Miss Khapp. Sang "Jesus I long to be perfectly whole." Prayer by Rev. A. N. McEwen. Mrs. Byrd was called upon the continue the discussion on paper entitled "Impressions" the tile use on Miss Banche.

Rev. J. M. Mason then read his paper entitled "Woman's part in denominational work." It was full of rich thoughts

and timely suggestions.

The time having arrived for adjournment, it was moved and seconded to extend the time fifteen minutes for discussion on the paper. Rev. A. N. McEwen, of Montgomery, used the whole time. After reading the programme for night service, the convention adjourned to meet at seven o'clock. Prayer by Rev. D. T. Gulley.

FRIDAY NIGHT.

Brayer meeting was led by Rev. D. T. Gulley. After several prayers and songs the time for business having arrived. Mrs. Bowie called the meeting to order and the

program for the evening was begun.

After music by the choir Miss Lula I: Watkins of Montgomery, read a paper entitled "Woman's part in the education of the race." At the close of the paper Rev. W. H. McAlpine raised the humn. "Must go, and empty handed." The whole congregation joined in and sang. The paper was grand one, giving in full woman's part in the education of the race. Much enthusiasm was created and then

followed a lengthy discussion of the paper, opened by Mrs. Pitts, of Uniontown, the following taking part in the discussion: Rev. A. N. McEwen, Mrs. S. H. Wright, Mrs. Callen. Rev. W. H. McAlpine, Mrs. Owens, Mrs. Tyler, Mr. Leftwich and Mrs. England.

It was moved and seconded the discussion be closed.

Carried. The choir then gave some music.

Rev. W. H. McAlpine then introduced Dr. C. L. Purce, President of the Selma University, who lectured from the subject "Selma University and the relation of the Woman's Convention to it." He held the convention spellbound for an hour and a half in his usual happy vein, suggested many practical thoughts. After close of the lecture the choir sang some beautiful songs while the collection was being taken. A collection of \$11.10 was taken. After reading the programme for Saturday morning, adjourned to meet Saturday morning at 9 o'clock. Benediction by Rev. W. H. McAlpine.

SATURDAY MORNING.

After prayer meeting, led by Mrs. Bettie Pitts, of Wetumpka, Mrs. Tyler, Vice President, called the convention to order. Sang hymn 116 G. H. Rev. W. H. McAlpine read the scriptule in concert with the convention, using the 23 Psalm and part of the 24th Psalm. Sang 202 Gospel Hymn 176. Prayer by Rev. A. N. McEwen.

Then followed the reading of the minutes. It was moved and seconded to receive and adopt the minutes. Quite a lengthy discussion followed, but as it was found

that the minutes were all right they were adopted.

Mr. Callens then moved that the report coming from the Committe on Permanent Organization be reconsidered. Carried.

The reading of the report of the committee was then called for. It was moved to adopt by sections. The first section was then read, which was as follows: "We recommend Mrs. A. A. Bowie for President, Mrs. A. Tyler for

Vice President."

It was then moved that the name of Mrs. Tyler be inserted in place of Mrs. Bowie, and Mrs. Bowie's name in place of Mrs. Tyler's. A rising vote was called for. Sixteen voted to have Mrs. Tyler President, and two for Mrs. Bowie. Mrs Tyler was then declared President. It was then moved to adopt the report as a whole. Carried.

Reading of letters was then resumed. A letter was read from Sister Anna M. Brooks, ex-President, when the following resolution was offered:

Resolved 1st, That we thank Sister Anna M. Brooks for

her earnest work for three years as President.

Resolved 2d, That we regret exceedingly her inability to be present with us at this session. That she will ever live in our hearts in grateful remembrance for her services to us, we will remember her in our prayers and we hope to have her presence at the next session of the convention.

It was moved and seconded that the resolution be adopted. Carried.

These were then enrolled: Miss Nellie Jones, Ham-

burg: Miss Murilla Waugh, Uniontown.

Sister Evans then read an essay, which was very good. It was then moved and seconded that we hear from Rev. C. L. Fisher in regard to his work as theological teacher. He came forward and gave an outline of his work.

Mrs. Bowie then spoke to the question, followed by Revs. A. N. McEwen, who spoke of the preacher as "poor devils." Rev. W. H. McAlpine took exception to being called "devils." Mesdames Callens, Purce, M. A. Lockett, Bowie and Dr. Purce then make remarks as to the work of the Theological Department.

Mrs. Bowie was then called to the chair. Rev. W. C. Bradford and Mr. Leftwich were brought forward and introduced to the convention. Both made a few remarks.

Mrs. Tyler then suggested that the Women's Convention set apart a day that a collection be taken for the Theological Department. Mesdames Jones, Matthews, Waugh, Miller and Pitts all spoke in favor of the plan suggested by Mrs. Tyler.

It was moved and seconded that the discussion be closed. Carried.

Time was then given for a subscription to be opened for the Theological Department. The time for intermission having arrived, it was moved that any member of the convention being late, be fined one dollar. Carried. An intermission of twenty minutes was then taken.

After intermission, prayer by Rev. J. M. Mason. After singing Rev. J. M. Mason made a few remarks in parting, as he was expecting to leave.

Mr. McEwen's paper was then called for. Subject—the "Baptish Leader." He had not prepared a paper, but he opened the discussion. As the time was short, he having to leave, he did not have time to get subscribers. Rev. McAlpine, Rev. Purce, Mrs. Bowie, Miss Europe and others spoke on the paper. Miss Europe moved that something be donated to the paper; seconded by Mrs. Byrd. Carried.

The time for adjournment having arrrived and so much unfinished business, it was moved to have a night session, Carried. The convention adjourned to meet at 7 o'clock.

SATURDAY NIGHT SESSION.

Pursuant to adjournment the convention met at 8 o'clock, Mrs. Tyler President, in the chair. After music by the choir, Rev. W. H. McAlpine led in prayer. After more music by the choir Mrs. Gulley's paper was called for. She being absent, Mrs. Bowie was called for to open the discussion.

Subject—The advisability of dividing the State into districts, Mesdames Harriet Nichols, S. H. Wright, and Bowie and Rev. W. H. McAlpine taking part in the discussion. Mrs. —— was then call to the chair and Mrs. Tyler spoke on the subject. It was moved and seconded that the discussion be closed and the matter referred to the Executive Board. Carried.

The Committee on New Bodies being ready, submitted

their report. See report.

Mrs. Bowie then offered resolutions, which were referred to the Committe on Resolutions.

The Committee on Time and Place being ready, submitted their report.

REPORT OF COMMITTEE ON TIME AND PLACE.

MRS. PRESIDENT-We, your Committee on Time and

place beg leave to submit the following report:

We have received invitations from Demopolis and Birmingham. We, your committee feel that since the convention has never been in the southwestern part of the State, we recommend that we meet with the New Morning Star Baptist Church, of Demopolis, Ala., on Thursday before the fourth Lord's day in June, 1892.

Mrs. Callens moved that we go to Demopolis. Seconded. It was also moved to amend by inserting Birmingham in place of Demopolis, but after some discussion the amendment was withdrawn, and the original motion was put and carried. There being no further business, adjourned to meet Sunday morning in mass meeting with the Sunday school.

SUNDAY MORNING,

JUNE 28TH, 1891,

The convention reassembled with the Sabbath school in mass meeting. The Superintendent, after distributing the new quarterlies, turned the Sabbath school over to the Convention.

Mrs. Wright was called upon to conduct the mass meeting. Topics were assigned as follows: Rev. W. H. McAlpine—The lessons; Mrs. Bowie—How to be successful as a teacher; Mrs. Owen—How to awaken an interest in Sunday school work.

Rev. W. H. McAlpine gave quite a careful review of the lessons. The time being spent, a collection of \$5.55 was taken.

The time for services having arrived, Rev. W. H. Mc-Alpine went to the pulpit and after music by the choir, gave one of his very best sermons, which was listened to with marked attention. His text being second Song of Solomon and 1st verse, "I'am the rose of Sharon and lilly of the valleys." After the sermon a collection of \$10.35 was taken. Benediction by Rev. J. Q. A. Wilhite.

At 3 o'clock p. m., Rev. J. Q. A. Wilhite preached. A collection of \$3.21 was then taken.

SUNDAY AFTERNOON.

Pursuant to adjournment Mrs Bowie called the convention to order.

The report of the Treasurer was then read. (See

Then followed report from Financial agent. (See report.)

The report of the Board was then read. (See report.)

It was moved to receive the report coming from the Board.

While waiting for the committees to report the con-

vention had an experience meeting.

After hearing reports of the several committees the convention adjourned to 7 o'clock.

SUNDAY NIGHT.

The convention reassembled at 7:30 o'clock, Rev. J. Q. A. Wilhite leading the devotional exercises, after which Rev. C. L. Fisher preached a very interesting and instructive sermon from these words: "Thy Kingdom come." It being one in a series of sermons on the Lord's prayer.

A collection of \$23.96 was then taken up, after which

the following resolutions were offered:

Mrs. President and Members of the Convention:

WHEREAS, The members of this Church, friends and citizens, have shown us so much kindness and have entertained us so pleasantly during our stay, therefore be it

Resolved, That a vote of thanks be tendered the society, Church, citizens and friends of Eufaula for hospitality shown

Delegates and visitors to the convention.

Resolved 2d, That a vote of thanks be given the choir

for its excellent music rendered during our services.

Resolved 3d, That a vote of thanks be tendered the railroad authorities for their kindness in giving us reduced rates.

AND WHEREAS, The work of this convention embraces not only the work of Christian education, but the great mission work.

AND WHEREAS, The thorough organization throughout the sisterhood in the State is needed,

AND WHEREAS, The work cannot be prosecuted without at least \$2000 for the next conventional year, therefore, be it

Resolved. That this convention appoint an efficient agent whose duty it shall be to travel over the State and visit as many churches as possible.

Resolved 2d, That an effort be made to secure the cooperation of all our pastors in organizing the sisters through-

out the State.

Resolved 3d, That a day be set apart and be known as "Sisters' Day," and that an effort be made on that day to raise at least \$2000.

Resolved 4th, That the Financial Agent be empowered to print and distribute circulars throughout the State; giv-

ing information and instruction about the work.

Resolved 5th, That the churches be requested to give at least one service for the sisters on "Sisters' Day," and that suitable programs be suggested for "Sisters' Day," and that pastors be earnestly requested to co-operate with the sisters and to help to make "Sisters' Day" a success.

Resolved 6th, That the Financial Agent, as far as possible, in connection with raising money, do mission work, holding Bible readings, prayer meetings and in whatever

way she can best advance the mission cause.

Resolved 7th, That the Financial Agent visit conventions, associations and annual meetings, and lay before them the work of the sisters.

Resolved 8th, That the agent will gather statistics of the Womens' Work.

Resolved 9th, That a sufficient number of minutes be printed to give each church at least two or three.

It was read and adopted.

The question blative to the amount due Bro. Wilhite was raised, and, after a lengthy discussion, it was moved and

carried that the Board pay Bro. Wilhite one half of the amount due him and at as an early period as possible to make a payment.

A* motion was made and carried for adjournment.

JUNE 26th.

The meeting was called to order by Mrs. Bowie for the purpose of hearing read the Treasurer's report, which, after hearing read, was favorably passed by the Board, with the exception of the difference of the debt due to Mr. Schuster.

The Financial Agent read her resignation, which was received and adopted.

## CONSTITUTION:

ARTICLE I.-NAME.

This body shall be known as the Baptist Women's State Convention.

#### ARTICLE II.—OBJECT.

The object of this Convention shall be to promote the cause of Christ by laboring for the upbuilding of Selma University, and by doing such mission work as is possible.

## ARTICLE III.-MEMBERSHIP.

- § 1. Any Women's Society, whose members are connected with a regular Baptist Church, and women in good standing with their churches may become members of this organization.
- § 2.—Any women in good standing in the Baptist Church may become a Life-member, by the payment of Five (5) dollars, or an Annual-member, by the payment of One (1) dollar. All societies are requested to send annually to the Convention Ten (10) cents per member.

§ 3.—Any male member in good standing in the Baptist Church, may be received as an honorary Life-member, by paying Five (5( dollars, or an Honorary annual member by paying One (1) dollar.

§ 4.—No society shall send a male member to the Convention; none but women shall be all wed to vote or hold office.

## ARTICLE IV. OFFICERS.

§ 1.—The officers of this society shall be President, Vice-President, Recording Secretary, a Corresponding Secretary, Treasurer, and Board, consisting of fourteen members,

§ 2.—The President, Vice-President, Recording Secretary, Corresponding Secretary and Treasurer shall perform the duties which usually fall to said officers in similar bodies.

## ARTICLE V.-BOARD.

The Board of fourteen members, including the officers of the Convention, shall have the power to carry out the object of the Convention, and in general to do anything necessary to secury full and complete organization of the women of the State, provided always that they conform to this Constitution. The Board shall have its headquarters at Selma, and five (5) members shall constitute a quorum.

#### ARTICLE VI. - ANNUAL MEETINGS.

This convention shall meet annually on Thursday before the fourth Lord's day in June.

#### ARTICLE VII.—AMENDMENTS.

This Constitution can be amended at any annual meeting by a two-third vote.

#### BY-LAWS.

This Convention shall be governed by such by-laws as usually govern religious bodies.

#### SOME PLANS FOR RAISING MONEY.

DEAR FRIENDS:—Lord Bacon said: "The greatest trust between man and man is the trust, of giving counsel." One class of people know what to say, but not how to say it. Others know what to say and how to say it, but they know not when to say. I consider myself thoroughly competent as to the when, but thoroughly incompetent as to the what and to the how. The when is now, as you will all agree, but the how and what I know not. My object is indefinite. I was requested by your honored committee to write a paper on place for raising money. I am not confined to a special object for which money should be raised. I am like unto a non thrown over-board in a dark night, with simply the pasing advice, "Swim for your life." I

am not told which way to go, and, in my bewilderment, I am more liable to fall in line with the drift-wood than I am

to swim to the nearest shore.

There are two things that all mankind agree on—the necessity of friendship and the use of money. The recluse sequestered in his cloister may feign to disdain money, but the click of a few \$20 gold pieces will sound in his ear with a Heavenly ring as charming as the music of an Eolian harp. While preachers boldly denounce mammon and the money greed of the 19th century, they moderately tone down when time comes to take a collection they do not denounce the use but the abuse of money. The united prayer is money, many, more and more money. "Money is power." A man with a bank account is usually admitted into all business circles; heeded when he speaks and honored as he passes. I would say in passing to my subject that our people need to put a higher estimate upon money. Let us accumulate money and use it for God and humanity. But what we need is the Lord's money. Let us be understood on this What is meant by the Lord's money? The money that belongs to God's children. When we first experienced that change called the new birth, we solemnly gave ourselves and our money to God. Christianity started upon this basis. Look at the primitive church in those days; when a man was baptized his money was also baptized. When a man joined the Church, his money was laid upon God's altar, the influence of the holy spirit working in the heart caused the man to dig up his gold long buried in the earth and place it at the feet of the Apostles before he would be asked to be fellowshipped by the Church. There is enough money in the hands of are not our own, God's people to do a work that could startle devils, astonish men and fill the Angels with amazement. We are only stewards of what we have, and God will take account of our stewardship. I say we want God's money. Money that carries with it is the blessing of God. God not only loves a cheerful giver, but He also accepts the gift and places if to our credit and then sends it out from His presence with His benediction. Let us not rob God, but crowd His storehouse with that which is His, and then claim. a large blessing as we go out from his presence.

I now come to the object for whe raised. To begin at home, I would

money should be we need more of the Lord's money, to run our Sunday schools. We need money to purchase organs, buy S. S. literature, help the poor children of our school; need money to buy literature, to distribute in destitute regions where children are too poor to buy Bibles and song books, more money to support our Sunday schools, if we are to have greater results. And then we need more money to run our Churches. Our pastors should be paid better salaries. Our missionaries should have better support; our choirs should be aided so that they could make the services more enjoyable by furnishing good music. Some of our houses of worship need repairs, and others need putting down and new ones put up. And we need to look after the poor of the Church. One of the reasons why so many Christians belong to benevolent societies is the Church does not lookafter the poor. We need money for our home missions and more money for foreign mission work. There are destitute regions in our own land, and the Maccedonian cry is "come over and help us." Christians are throwing away thousands of God's money on excursions and in extravagant living. God is crowding our doors with these demands and writing against us for our unfaithfulness. God grant we shall not wait for the handwriting on the wall to reveal to us that we are weighed in the balances and are found wanting.

Now, we will consider Christian education, which is the burden of the Church work. This is the burden of the Church that reason to promote Christian education. We have private schools taught by teachers of our own choice. A few Baptist academies and and a grand University of our own in Selma. And, then our State paper, the Leader, has a larger claim upon us than we realize, the Home Mission Society and the Baptist Publishing Society that spends its thousands every year in our State, helping us in the grand work of education. They need money, and our sympathy and co-operation. But I recur to our Selma University. We need more money to place this school, where it ought to have been years ago. We need \$25,000 for building, \$5,000 for library, press, school aparatus, etc. And our teacher should have better salaries. The Home Mission Society is doing more than its share of the work, and we are doing less than our share. It is a marvel that our school goes on a smoothly. But you say \$30,000 is a great sum of month for these hard times. Grant it, but look at the Colored apptists in our State.

#### PLANS.

We will take the estimate of our own strength made by some our most competent men several years ago. They put our strength at 125,000 communicants. An average of 25c. per member would place in the hands of the Board of Trustees the sum of \$31,250. Think of it. An average of 25c. per head of the Colored Baptist of Alabama would pay for the new building and fornish all the money at present. I have thus far spoken of money and objects for which money should be liberally contributed. Now, notice plans for raising money. It is thought to be the most difficult thing in the world to formalate a plan to suit alike all the This is true so far as it refers to the matter of Churches. raising money to run Sunday Schools and Churches. Recognizing these difficulties, we will not undertake to offer any suggestions on that line. But, concerning ourselves about plans to raise money for our Selma University, first. we need to concentrate our efforts upon one particular object. We must study, arrange, combine and execute. range our plans for a special work, combine our forces and This, with the blessing of God, will execute our plans. give us success. The Emperor Nicholas, it is said, ordered his engineers to lay down for him a railway from St. Petersburg to Moscow. Presently, the engineers brought him a large card paper on which was laid down, like a snake, the designed path for the road between the capitals. "What is that?" asked Nicholas. "That is the best road." was the reply. "What did you make it crooked for?" "Why, we turn this way to touch this great city and to the left to reach that immense mass of people." The Emperor turned the card and made a new dot for Moscow and another for St. Petersburg, took a ruler, made a straight, line from one dot to the other, and said: "Build me that road." "But what will become of the depot trade of that town?" "I don't known," said the Emperor. "They must look out for themselves," and that Emperor was wise. God does not require us to turn this way and that, finding the whole time in planning and altering our plans. He marks out a plan for us and tells us to follow it. He comes to our consciences, and to our hearts and makes a straight line and says to us: "Build for me Selma University." Let us concentrate our efforts in building alma University by raising at least 25 cts. from each Coured Baptist in Alabama. - Let us ask the State Convention to unite with us

in taking the census of the Colored Baptists in our State by collecting 25 cts from each. Let ms ask the different associations and Sunday school conventions, and churches, and pastors and missionary societies to unite in this grand effort to raise \$3,000. Judging by the success the Baptist women had in raising \$3,000 for our jubilee, we are assured of success. Let us do this because we can do, and because we ought to do it, and because there is need of doing it. Let the women of this convention have their headquarters. appoint secretaries and agents and confer as far as practicable with all of our leading men and women in all of our churches and associations. Let the Baptist Leader publish our plans, and we assist in circulating that paper until the editor shall be compelled to publish 10,000 copies every week. The field is ripe, and the work is ours, and consecrated Christian women never fail when they have wisdom in their plans and the law of God in their hearts. never lays the burden of a great work upon a people without making a way for that work to be accomplished. The road to glory would cease to be arduous if it were trite and troddy, and great minds must be ready not only to take opportunities, but to make them. Alexander the Great cut the Gordian knots which others had in vain attempted Those who start in a great work for God and humanity, like the mettled hands of Octarian, must pursue the game, not only where there is a path but where there is none. They must be able to leap and to creep and, like Nelson, snatch the laurels from the doubtful hand of victory, while she is hesitating where to bestow them.

Let us build Selma University.
