The recent two months, tour of our South American fields was intensely interesting and helpful, and I am more convinced than ever that here lies one of the most responsive fields in the world. The Baptist constituency of Brazil is approximately 100,000 at present, and growing constantly.

Regarding representation, the following individuals have been elected by various national groups: Rev. H. C. McConnell from the Chilean Baptist Convention, whose application I am enclosing. Unfortunately it is not signed by the secretary of the Convention, but I have definite evidence that he was elected officially by the Convention and will represent them well. The only national who might have been sent is Mr. Honorio Espinoza, who attended a previous Alliance meeting. Mr. McConnell is a graduate of the University and the Louisville Seminary. He is a very thoughtful speaker.

For Argentina and the River Plate (including Paraguay and Uruguay), Rev. Alfonso Olmedo has been elected. He is a graduate of the New Orleans Baptist Theological Seminary, is strongly evangelistic, and speaks English exceedingly well. He is the president of the River Plate Baptist Convention and will be a fine representative. I can recommend him highly, both for his thoughtfulness, his ability, and his spirit.

From Brazil, we are hoping to be able to send Dr. John Soren, the pastor of the First Baptist Church of Rio de Janeiro, which is the largest Baptist church in all of Latin America, with a membership of nearly 2,000. Dr. Soren is the son of the former pastor who was so well known to Southern Baptists for many years. Dr. Soren is likewise a graduate of the Louisville Seminary, is a former president of the Brazilian Baptist Convention, and now serves as vice-president; the only Baptist chaplain serving with the Italian forces on the Italian front during the Second World War; was decorated by

at present, and growing necessary in

the Brazilian and American governments; speaks English splendidly (his mother was an American), though he is an ardent Brazilian himself.

When I was in Brazil recently, the South Brazil Mission recommended that we pay onehalf of his expenses, with the understanding that his church would pay the other half. I am waiting to hear from him, but I am fairly confident that he will go, even though we have to advance some additional funds. I think it would be in order to write to him directly. I left application forms with the Mission and I am sure that he will be sending them in shortly. Unfortunately, the Brazilian Baptist Convention only meets every two years, so it was impossible for the Convention as such to elect a representative. He is a very able speaker, both in Portuguese and English, and will represent the largest Latin American group in the world.

I am still hoping that it will be possible for you to visit these areas in the coming months or years, and I want to assure you again of our desire here at the Board to be of every possible assistance.

Dear Friend:

I have received your letter of March 27th concerning the suggestion of Dr. Sadler as to financial assistance to be given to Mr. Jansma and Dr. Hardenberg of Holland, to attend the meeting of the B.W.A. in Cleveland.

You are right in assuming that the money contributed by the Boards towards a pool has already been allocated, but the Alliance has at its disposal a modest sum of undesignated money, which the Administrative Committee at its last meeting on February 28th authorized Dr. Lewis and myself to use towards helping others outside of Germany and Austria.

It seems that we shall have to give some assistance to delegates from Switzerland, France, Holland and Finland. The money will probably be appropriated with a view to encouraging the Baptists of these countries to do something themselves towards assuring a representation in Cleveland.

Dr. Lewis and I have been in correspondence concerning Holland, and we concur in the opinion that Hardenberg would be a good man to have here. A couple of days ago I wrote to Dr. Lewis that we shall try to secure some money towards helping him to come. Dr. Lewis and I have no objection to Jansma coming, but we do think it more important that Hardenberg should come. You may recall that he is a member of the Board of Trustees of the Seminary in Zurich.

The sum I think Lewis will be offering Hardenberg is about \$200.00, which would take care of his expenses one way and leave a little over, but not enough for expenses in this country, or for his return trip. If you happen to know of some person who would be willing to help some representatives from the countries mentioned above, the B.W.A. will, of course, be very happy to be of any service we possibly can in distributing such money.
