The Ex. Com. of the Baptist
State Mission Board met
in regular monthly business
session with the following

Agenda:

H. M. Sumford, R. W. Weaver,
C. K. Bright, J. E. Skinner,
W. H. Gillon, R. W. Hale.

The meeting was opened
with prayer by Mr. Bright.

The minutes of the previous
meeting were read and ap-
proved.

The Com. allowed \$300.00
by the support of Rev. C. S.
Boone, on condition that the
women pay it, as part pay-
ment for his services as
city missionary in Memphis.

It was also moved and
seconded that \$100.00 be allowed
to the Leekherd Church toward
paying the salary of Rev. J. M.
Byrom as Pastor.

A motion was made that
\$200.00 be allowed the Enon
Association toward paying
the salary of W. A. Russell as

Association Missionary. The
Emon Association having
made this request as they
contemplate employing Bro.
Cuswell for two thirds of his
time. It was recommended
that Sec. Ginn investigate the
situation and if after his
investigation he felt warrant-
ed in assisting the Association
to this extent that he should
have the discretion of using \$

The State Mission Board met
in quarterly session with Dr.
Sumford, the Chair. Those
present were:

The minutes of the previous
meeting were read and, with
one exception, approved. Dr.
Haver opened the meeting with
prayer. Dr. Gilson read the
Address which he has prepared

to send to the various factories
over the state urging special
effort for missions.

Dr. Gilton presented a bill
of \$2.75 from Sec. Ball
for stationery. The Board
instructed Sec. Gilton to
write Bro. Ball that it
was not customary to furnish
stationery for the Recording
Secretary, and that the
Board thinks it should not
be asked to pay this bill.

It was moved and ac-
cordingly that the action
of the Ex. Com. as set out
in the minutes be ratified
by the Board. Meeting
adjourned with prayer by
Bro. Wright.

The regular quarterly meet-
ing of the State Mission
Board of the Baptist Con-
vention for Term. met Tuesday
afternoon, May 4th 1915 at
2:10 o'clock in the S. S. Board
room. Dr. Wm. Sumford presided
The meeting opened with
prayer by J. E. Skinner.

The following members were present: -

J. W. Gilson, E. E. Folk
J. E. Skinner, R. W. Weaver,
Allen Fort.

In the absence of the Sec. Allen Fort was asked to act as Sec. for term.

Sec. Gilson made a verbal report of the work done by him and by the office force during the past three months.

There have been months of aggressive evangelistic efforts with good results, and likewise strenuous months in the campaign for Home and Foreign Missions.

In view of the financial conditions now prevailing a motion was made by R. W. Weaver that the Sec. be instructed not to expend any more money, nor incur any other obligations than those already appointed and approved. Motion carried.

An application from the Baptist Church of Smyrna made to the Home Mission Board,

asking for a gift of \$1,000.00 towards the payment of the debt on the building was presented to this body for its approval. A motion was made by J. E. Skinner and duly seconded, approving the application and asking the Home Mission Board to grant the request.

A motion was made by E. E. Folk that the Board appropriate \$300.00 to the W. Com. of Sevier County Association for Missionary purposes. The motion was seconded, and after discussion, was carried.

Allen Fort voted against the motion on the ground that the money, while given to Missionary purposes was in reality for the school building to be erected by the association, and he thought this a misappropriation of money given to State Missions. In his opinion it was not a proper execution of the trust provided in the State Mission Board.

The following persons were appointed as messengers from Term. to the Southern Baptist Convention to be held this month at Houston, Texas.

Sec. Gillon was authorized to add such other names as might be presented him up to the full quota of representatives from this State.

A motion to adjourn was made and carried. J. N. Penick led the closing prayer.
