



## The Miami Convention

### THE PAINS OF PROGRESS

Someone has well said that "Nothing succeeds like success." When we think of the inevitability of change—that experience in our lives which makes for growth, we are suddenly brought face to face with the stern fact that the very name of the term "progress" suggests pain, disappointment and suffering. To sit through an election in a church body as influential as that of the National Baptist Convention, U.S.A., Inc., can be a meaningful experience as well as a rare opportunity. Truly a large group of our constituency participated and yet, the majority of our lay constituency was not present and has never witnessed at any time in their lives an election of our national body.

To those of us who were present, there was an opportunity to see this great drama of life from many viewpoints. To the careful observer, one could see power and strategy combined to play a role in the fulfillment of avowed purposes on the part of those who either took the drama in one or two ways, from a more serious view or from a lighter view. To the unscrupulous, it was an effort to achieve what the supporters and those who were in the running felt was correct. To others more serious minded, one could see the justice of God, a ripening purpose being fulfilled in spite of themselves.

### HEADLINES WHICH HURT

Perhaps never before in the history of our Convention did so many of our leaders make headlines. Prior to the opening session, an unprecedented number of our leaders openly offered themselves for service. Others, while not openly expressing it, held their breath and (dreamed) nursed a hope in their own favor if and when the unusual and unexpected really did happen.

When the election was over, sentiments mingled with joy, disappointment and even surprise were evident. Some of those who were in the forefront, I feel, were actually hurt because they saw this inevitable change taking place in our Convention; others disappointed because in the end it did not seem to take recognition of their life and worth so as to include them. While there were others who went away rejoicing that they were the people's choice and yet just a little apprehensive that Providence had brought them to the Kingdom at such an hour as this.

### A FAR-REACHING PROGRAM

Since 1922, we have watched our Convention in its slow but sure march of progress. Men have come and gone and we grow larger each day and each year. This 73rd session of ours made history in the provision of a worthy president who honorably retired and the election of an able leader who has the foresight and future to lead us on to unprecedented heights. And moreover, his proposals in the creation of a committee on international and intercultural relations, on the United Nations, on current and civic issues, on problems of labor and management, on denominational coordination, on theological education, and on problems of church-supported colleges convinced us all that we were once again going in the right direction, following a great leader like the National Baptists have always had and which only National Baptists now or in the future will follow.

### HOW SUCCESS SUCCEEDS

During these thirty days which have expired since President Jackson's election, National Baptists might well be petitioning God for our leaders; that they shall have the fullest cooperation, Godly guidance, strength, wisdom and vision to continue in the leadership of our church in a

## Alumni Breakfast Breaks Precedence

Each year in connection with the annual session of the National Baptist Convention, the Seminary sponsors a breakfast for alumni, their families, and invited guests and friends.

The breakfast this year was planned by the Rev. L. J. Burt, pastor of the Beulah Baptist Church, Atlanta, Georgia, with the assistance of the secretary, Rev. William Howe Donaldson and faculty members at the Seminary. After a brief program on which alumni and friends brought greetings, the group consisting of 96 alumni settled down to a delicious breakfast on the beautiful terrace of the Lord Calvert Hotel.

Among the many things worth-while which may come as a result of an alumni breakfast each year, nothing I think can be more important than the opportunity to fellowship, the joy of meeting newcomers to the Seminary family and the privilege again to relive in the larger world, some of the experiences of Seminary life. A.B.T. alumni not only did just this, but gave evidence of being greatly pleased and appreciative of the progress being made at the Seminary, and commended President Riley at this time for his constructive leadership at the Seminary. At a subsequent business meeting of the Association, the members took recognition of the passing of Rev. G. W. Tolbert, B.Th. '42, and sent a message and donation to his wife, Mrs. Tolbert, at Port Arthur, Texas, where Rev. Tolbert served as minister of the First Baptist Church.

Sponsorship of the Garnett-Nabrit Lectures, larger support to the Seminary, plans for recruiting more students to the Seminary, and an effort to secure more funds for scholarships were some of the items of business considered in the meeting.

Greetings by Dr. Porter Routh, fraternal messenger from the Southern Baptist Convention to the National Baptist Convention; Dr. J. W. Parrish, minister of Shiloh Baptist Church, Columbus, Ohio, and trustee of the Seminary; other guests and President R. W. Riley, were brought to the body.

While there was a large group in attendance, the absence of some of the most ardent Seminary enthusiasts was conspicuous. The reason for this however, is because of the prominent places in Convention administration held by these men which made it impossible for them to be present. But those who were not present expressed regret that they could not be present and some not only sent contributions, but a scholarship was provided for a worthy student from all those who could be present.
