## PORNOGRAPHY

Editor's Note: The following message was delivered at a Rally and Hearing before the Gastonia City Council and members of the Gaston County Board of Commissioners. We face the pornography battle all across the State and what the author has said in this paper should be of interest to every Christian across North Carolina.



Recently, Indiana State Senator Gene Snowden, Founding Chairman of the Council for National Righteous-ness, said, "More than half a generation of our youth have been virtually incapacitated to make moral decisions. If we lose the next half generation, the

battle is lost."

Of recent years, the United States, and indeed, the whole world has been greatly by the threat of pollution. We have many laws and regulations on the statute books which permit a city, county or state to ban the burning of leaves, or other trash because it pollutes the atmosphere. Businesses must control the emission of pollutants from smokestacks and power plants. Automobiles, by law, must be provided with anti-pollutant devices. All of this is good. We want to be to live and grow without the threat of pol-

But what about pollution of the mind and spirit? Is there no concern at this point? Of course there is. People everywhere are becoming aroused because of the concerted effort of those who stand to profit by providing the materials which can and do pollute the minds of both youth and adults. There are many who are unwilling to stand idly by and do nothing when the morals, the ideals, the very human relationships which are the cement of society, are all threatened by the octopus of pornography and smut. There seems to be good evidence that the creation, the production, the sale and the distribution of the majority of pornographic and obscene materials films, books, and magazines - are under the control of the Mafia. This has become a billion dollar industry, and one of the most profitable known.

#### LEGISLATE MORALITY

Someone recently said, "I am told that you can't legislate morality." My answer is, maybe you can't, but you'd sure enough better try. It has become increasingly evident that evil increases radically with its legal decriminalization. The lack of laws against gambling, drugs, homosexuality, pornography, obscenity or any other social evil is always interpreted by those who traffic in these things as the publics' tacit approval. Those who ardently seek to suck, like leeches, the very lifeblood of the community, vociferously argue against any kind of law or control. That is to be expected. They want nothing to interfere with their nefarious and lecherous business.

Unfortunately, groups such as the American Civil Liberties Union ride to their defense in the name of personal freedom. They paint a dark and stormy picture of any society which seeks to prevent by law or regulation the turning of liberty into license. And they continually carp that "You can't legislate morality." What they forget is that every law which in any way controls the actions of individuals is based on morality. The laws against murder, stealing, embezzlement, shop-lifting, purgery, and many others, are all laws that seek to legislate morality. You need no law against killing for the person who loves his fellow men; he will hurt no one. But we have to have laws to attempt to control those who have no concern for others, or, in truth, for their own well-being. rules that at some point intervene in certain so-called rights. Here in our city a land-owner cannot build a fence higher than four feet along his neighbor's line, even though it be an ordinary wire fence. Why not? It's his land, and the fence is on his property, and it hurts nobody. But the city says that if it is higher than four feet it infringes on the neighbor's rights. A church cannot build a building, nor can a business, without first assuring the city that there are ample parking places based on the number of people who will use that building. Why not? It's their land and their money. But the city says the community has a vested interest. Every building which houses people for any time, must meet certain fire and health regulations. There are regulations against the height of radio and T.V. antennas. And there are a thousand other such regulations - laws, if you please. In every one of them, somebody could say, "That infringes on my rights." But "my rights" must be submerged under the rights of the populace.

With the war-cry of "no censorship," and the question, "Whose Morality?" the so-called intellectuals, and would-be defend-ants of freedom, have brought their shallow self-gratifying, and even sometimes seemingly communist philosophy to the multitudes. No censorship simply means no standards. Every newspaper ever printed, and every book ever written and published, and every magazine printed at some point is subject to somebody's censorship and editing. The newspapers that rant against censorship will never publish one word without subjecting it to somebody's judgment as to whether it fits the plan and philosophy of the paper.

### SOROKIN'S REMINDER

Dr. Pitirim Sorokin, noted Harvard sociologist, reminds us that if we do not maintain some standards, we may be overcome by the sexual anarchy that engulfed Greece in the second and third centuries before Christ. He says, "Men in those days prided them-selves in promiscuous behaviour. Adultery prostitution, homosexuality, and even incest were so common that those who indulged were regarded merely as interesting fellows."

Today's pornography is used as a base of erotic nihilists who would like to destroy every sort of social and moral law. Pornography is one of their trenchant weapons, foremost in its power to weaken the moral fiber of those who use it.

Several years ago, there was a conference between some of the more prominent American and Russian citizens, at which one of the Russians asked some pertinent questions. He said, "Why do your playwrights and authors insist on slandering your great country? Almost every motion picture we see about the United States does serious discredit and harm to your people. You are made to seem very vulgar and materialistic, as though you had no interest in the deeper things of life, which I know is not true .... I saw

And every relationship, whether with male or female, is always incapacitated by the inability to share the normal emotions of humanity.

We ask our officials to help protect us from this blighting, deadening, paralyzing poison of pornography and obscenity which will blind youth and adults to anything beautiful, clean and wholesome, and will destroy all sensitivity to what is good and

Some of these Colleges, when founded, were the hopes of conservative men in our Convention who dreamed of a college that would be different from those already established and operated by the Convention. It wasn't long though before these colleges came under the same liberal influence and also moved in the same direction of the older colleges and universities.

The hour is upon us when Southern Baptists who accept the authority of the scriptures, and the verbal inspiration of the scriptures need to found an Independent Southern Baptist College. When I speak of independent I take the chance of being mis-understood but I use the word in this respect, independent from the control, ownership, and financial support of the Southern Baptist Convention.

Of course, they deny to others the right that they claim for themselves. They decry what they call "pre-convention planning and campaigning" but the editors themselves do a great deal of it. They apparently would for Southern Baptists to swallow their ethical diachotomy that what is right for them is wrong for other people in the Convention.

### NORTH CAROLINA

The very first campaign propaganda North Carolina appeared on the back of the Biblical Recorder of March 20. It is written by Editor Chauncey Daley of the Western Recorder who has never been known as an enemy of liberals, to say the least. In the opening paragraph, he tells us how the Holy Spirit works (as if no one else knew). decries the fact that most of those who are selected for the office of President of the Southern Baptist Convention are usually'those with big churches, wide exposure and great oratory. "Of course, not many liberals into this category. Most churches pastored by liberals are dying. Only occasionally has a liberal turned up who was a great orator. Most of those men who would meet the above qualifications are conservative.

## "QUALIFICATIONS"

Mr. Daley then lists some qualifications (which are purely his own) for the man who would occupy the presidency of the Southern Baptist Convention. The first qualification Mr. Daley lists is "a proven and experienced leader". In discussing this he takes a back hand at "the charisma of popular preachers" (incidentally how can a man be pastor of a large church if he were not a proven leader). He maintains that such a person should have a commitment to the Lord and to the Scriptures and to Baptist ideals. Of course, the question arises as to what kind of commitment he must have. Every liberal says that he has a commitment to the Scriptures, to the Lord and to Baptist Ideals. Is that commitment a commitment to inerrancy? Are the Baptist Ideals those expressed in the Baptist Faith and Message? Discussing this qualification, Mr. Daley plainly rules out "ultra-conservatives" and the "less-conservatives" which obviously is a reference to the more moderate or middle of the road Baptists. So, neither those people whom Mr. Daley considers "ultra-conservative" or "less conservative" will do. It is strange indeed that he has not a single disparaging word to say about the liberals! You get the message don't you? Anyone associated with the Baptist Faith and Message Fellowship is to be considered an "ultraconservative" and hence, unacceptable. Of course, no one can be a member of the Baptist Faith and Message Fellowship without being a co-operating Southern Baptist - not necessarily a rubber stamp Southern Baptists. It is strange indeed that some denominational leaders consider it a grave sin to be a part of the Baptist Faith and Message Fellowship. Those who belong to the Fellowship are roundly condemned because they are part of an"organized effort". But, we wonder why those who are affiliated with the ultra-liberal Association of Southern Baptist Professors of Religion are not so condemned. That organization is not an official organization of the Convention but yet members of that organization are constantly called upon for writing assignments and other important denominational func-

## SEMANTIC JUNGLE

So, when one finally makes his way through Editor Chauncey Daley's semantic jungle, he could almost get the impression that he is campaigning against such men as Dr. Charles Stanley of the First Baptist Church of Atlanta or Dr. Adrian Rogers who is a great orator - who is pastor of the mammoth Bellevue Baptist Church where R.G. Lee once served - who is conservative - and who is well known because he is now President of the Southern Baptist Pastor's Conference. proven his great leaderability and he preaches Word in power. But, we are noticing a great deal of sniping at him in the Southern Baptist Press. Of course, his church is quite generous in giving to missions so he can't be accused at that point. He has been a loyal Southern Baptist supporter throughout his ministry but yet he seems to be too conservative for many of the State Editors. They seem to be mortally afraid that he might be elected President of the Southern Baptist Convention.

Who will emerge as the candidate of the State Paper Editors is not clear as yet. They usually try to settle on someone who makes enough conservative noises to be acceptable to everybody but who will be sympathetic to the liberal movement. We are noticing that the denominational press is quoting Russell Dilday and Bill Self quite freely recently. Both of them have been critics of the Baptist Faith and Message Fellowship. We predict that they will get a lot of "press" in the next two months and probably some last minute endorsements.

#### VOTE CONVICTIONS

We believe that it is time for Southern Baptists to go to the Convention and vote conviction. We should vote on the basis of Bible Doctrine and not on the basis of expediency. We need a man who believes in the entire and absolute trustworthiness of the Scriptures and who also has the courage of his convictions.

## DOUBLE STANDARD

We are seeing that old, tired, worn double standard emerging again in the discussions about Mr. Coy Privette and his qubernatorial candidacy.

There has been some hue and cry from various persons in the North Carolina Convention for Mr. Cov Privette to resign from the Presidency of the Convention if he is to run for the office of Governor. Much of this demand came from the more liberal element of the Convention, although there were really few demands considering the number of Baptists in the State. One letter to

resignation, associated him with the more right wing element of the Republican party. We hardly see how this could be true since Mr. John Stickley, a very well known Republican leader from Myers Park in Charlotte who has served on a number of convention boards and committees, is Mr. Privette's assistant campaign manager.

Now we have a thoroughly political book on Jimmy Carter published by Broadman Press our Southern Baptist Publishing House in Nashville, Tennessee. The book has an entire chapter entitled, "Presidential Plans". From start to finish, the book is an all out effort to seal Jimmy Carter as the Democratic Candidate for President. Now, we have no particular objection to Broadman publishing the book but we simply wonder why we have heard no protests from those who seem so concerned about the involvement of our Denomination or its leaders in politics. Of course, Jimmy Carter is somewhat to the left of Coy Privette. Could that possibly be the reason?

We believe that the Executive Committee acted wisely in rejecting demands that they for Mr. Privette's resignation. Secretary Ray was correct in pointing out that such an action would be actually saying to our people that only fringe Christians or non-Christians should run for public office. It is strange indeed, that some of the liberals who have been proclaiming for years that Christians should become more concerned about political affairs are the very ones who were clamoring for Mr. Privette's resignation. We still believe that "righteousness exalteth a nation". If it is true that the people of North Carolina want a true Christian in the Governor's Mansion along with clean and uncompromising Government, then they have their chance. Baptists should be thankful if the people of North Carolina choose to select the President of our Convention for the high office of Governor of North Carolina.

## culpepper to mid-america

The appointment of Dr. C.L. Culpepper, retired missionary to China and Taiwan as visiting Professor of Missions at the Mid-America Baptist Theological Seminary of Memphis is another significant development that will be welcomed by conservative pastors across the Convention.

Dr. Culpepper received a Bachelor of Arts from Baylor University, Theology and Doctor of Theology degrees from Southwestern Baptist Theological Seminary.

Dr. and Mrs. Culpepper were appointed missionaries to China by the Foreign Mission Board of the Southern Baptist Convention in 1923. Dr. Culpepper served as president of the North China Baptist Seminary in Shantung and the All-China Seminary in Shanghai. Following the Communist take-over in China, he became Treasurer of the Hong-Kong Baptist, Mission. He later transferred to Taiwan and served as President of the Taiwan Baptist Theological Seminary.Dr. and Mrs. Culpepper retired in 1965.

Dr. and Mrs. Culpepper have two children. Their daughter, Mary, serves as a Missionary to Japan and Charles Jr. is serving as a Missionary to Taiwan.

Dr. Culpepper's ministry of teaching at Mid-America is being hailed as an important step in helping the students to develop a wholesome attitude toward Biblical missions.

# Panel's findings rejected PORNOGRAPHY DEEMED HARMFUL

EDITOR'S NOTE: On the front page of this issue you will find a very strong presentation by Rev. M.O. Owens Jr. on the subject of pornography. Pornography is a disease that is sweeping North Carolina like wild-fire. The Christian Action League is not engaged in a program to raise \$30,000 to battle this malicious evil.

Presented here for your consideration is an article written by Ruth Redman who is associated with Citizens for Decency Through Law. She has pointed out some things that every pastor ought to be aware of. Pornography is not something that we can take lightly.

The proponents of pornography like to use the Presiden't Commission on Obscenity and Pornography as their "authority" on the subject, with never a word of how totally this commission was rejected. The President of the United States (Richard Nixon) said: "This commission has performed a dis-service and I totally reject its report." The U.S. Senate overwhelmingly rejected this report by a vote of 60 to 5. Scores of behavioral scientists, psychiatrists and psychologists also reject it.

As President of Citizens for Decency Through Law, I felt it important to study the findings of this commission. The effect panel suppressed its own research and erroneously reported its findings. One example from the Davis Braught research, a commission-financed study: "In the case of sexual deviancy, we have found a positive relationship between deviance and exposure to pornography at all ages of exposure levels" (never reported by the commission).

Another example, the Mosher-Katz research, studying male aggression against women in a laboratory setting, concluded: "The data clearly support the proposition that aggression against women increases when that aggression is instrumental to securing sexual stimulation through pornography" (not reported by the commission). Five more commission studies show definite evidence of aggressive arousal in subjects who were first aroused by erotic sexual stimuli (never reported). Also never mentioned was the fact that 254 psychiatrists and psychologists reported cases in which they found a direct casual link between involvement with pornography and a sex crime.

Behavioral psychologist Victor Cline, who has greatly researched the findings of this commission, says: "In sum, then a great variety of common errors, omissions, and drawing of incorrect conclusions from flawed research, as well as a manifest systematic bias in marshaling evidence and reporting it existed in the effects panel." Never in the history of this country was a national commission so totally rejected.

I wonder how many people are aware of the true nature of pornography - how many who consider it harmless, are aware of exactly what it is? Do we really believe these are harmless? Is it worth the risk? Is it worth one person being tortured or one child being seduced or raped or forced into these degrading acts with animals? What about those who are victimized into participating in these porno films and photos? I quote from a recent news article: "Pasadena police confiscated two trunkloads of pornographic photos of young boys and girls ranging in age from 7 to 12. Arrested was 41 year old David Payne, a photographer, who was charged with child-molestation, sodomy, and oral copulation." Pornography -- a "Victimless" crime?

The harmfulness to the viewer of pornography is explained and well-documented by many considered experts in their field. Those who do not accept this simply have not done their homework or choose to look the other way.

Ernest van den Haag, Ph.D., lecturer in sociology and psychology, practicing psychoanalyst says: "Pornography reduces or removes the empathy and mutual identification which restrain us from treating each other as objects or means. It excludes love, affection and any human relationship -- while it makes sadistic acts possible and even inviting."

Melvin Anchell, M.D. and psychiatrist, says: "In adults, even sexually mature ones, pornography has a sexually regressive effect. It encourages sexual behavior characteristic of perverts." He then explains the devastating effect of pornography on children, using as evidence case histories.

In my discussion of this subject recently with our county attorney, Eugene Kopecky, he commented that in every murder case in the last eight years in which he has been involved, with the exception of one, pornography was found in the home or vehicle of the defendant or at the scene of the

As citizens of this community, we do not have to allow ourselves to be victimized by this trash. The U.S. Constitution quarantees our right to "maintain a decent society" (Mills v. Calif., page 10). Every supreme court decision on pornography has emphasized that obscenity and pornography are not speech entitled to First Amendment protection. I quote: "This much has been categorically settled by the court,

The argument that pornography cannot be legislated against because it cannot be defined was struck down by the supreme court in the Miller decision when it laid down the necessary guidelines that each state must use in defining pornography. The justices encourage the states to pass such

all with children. One particularly vile These include the interest of the public in the quality of life and the total community environment" (Miller, page 10).

> The problem in our community is the lack of a good workable state law dealing with adult bookstores, massage parlors and triple X theaters. The supreme court has said we must have an "applicable state law". Our present state law deals only with minors and is very ineffective, and most definitely not "applicable". Many of our state legislators do not know the content of these porno outlets. Some who do, feel their constituents do not care. It is essential that we make our legislators aware of our deep concern and urge them to pass the necessary legislation this session.
