
VALENTINE HEADS COMMISSION

Dr. Foy D. Valentine of Dallas, Texas, has been elected Executive Secretary of the Christian Life Commission of the Southern Baptist Convention succeeding Dr. A. C. Miller. He will begin his new duties June 1.

Dr. Valentine has been director of the Christian Life Commission of the Baptist General Convention of Texas since 1953, when he also succeeded Dr. Miller, who left the Texas position to assume the Southern Baptist Convention leadership post in Nashville.

A native of Edgewood, Texas, Dr. Valentine received his Bachelor of Arts degree at Baylor University, Waco, Texas, and his Master and Doctor of Theology degrees at Southwestern Baptist Theological Seminary in Fort Worth, Texas.

Dr. Valentine's previous pastoral and denominational experience includes the following: pastor of the Jonah Baptist Church at Jonah, Texas, from 1942 to 1948; pagtor of the Golden Baptist Church at Golden, Texas, from 1944 to 1947; director of

Baptist student activities for colleges in Houston, Texas, from 1949 to 1950; pastor of the First Baptist Church of Gonzales, Texas, from 1950 to 1953; and special representative in race relations for the Texas Baptist Convention from 1947 to 1948.

Dr. Valentine is the author of a number of tracts on various aspects of Christian Life Commission work, including family life, race relations, moral issues, economic life, and Christian citizenship.

The Christian Life Commission is happy to welcome Dr. Valentine as its new Executive Secretary.

functions are described in the report of the Program Study Committee of the Commission.

- II. Proposed changes in the administration needs of the Commission have led me to feel that the timing is right for my successor to assume leadership of the administration of the Commission for these reasons:
- 1. The program of the Commission is under study by its committee and will be presented to the Convention through the Executive Committee in September, 1960.
- 2. The plans for new office quarters for the Commission are in process of development, but final decisions on arrangement have been postponed a year.
- 3. The present secretarial staff have changes in their plans which will leave the successor free to choose his own staff.
- III. Anticipating these program and staff changes following the meeting of the Southern Baptist Convention at Louisville last May, I began to look forward to my retirement in order to give the Commission an opportunity to choose a successor with adequate preparation to lead its expanding program. In seeking to arrive at a decision I sought the guidance of the Holy Spirit in earnest and prolonged prayer. He had led me to accept this position, and I knew that he would guide me and the members of this Commission in planning for my retirement. He has definitely led me to my retirement residence

A. C. Miller Retires

My decision to retire from the position of Executive Secretary of the Christian Life Commission and to enter a different phase of my Christian ministry and service is based on developments relating to the program of the Commission and of the Southern Baptist Convention.

- I. In view of the growth of the work of the Christian Life Commission, which imposes increased responsibilities on the Executive Secretary, I feel that the best interests of the Commission will be better served by my retirement at age sixty-eight and the employment of a capable and trained man in this position. This growth is manifested by the following developments:
- 1. Developments arising out of the acceptance by the Southern Baptist Convention of the report of its Committee on Total Program. This report, and the re-organization of Convention agencies required by its provisions, establishes for the Commission a more inclusive relationship to the Convention, which will permit the Commission to fulfil its functions in a broader and more intensive program of service.
- 2. Developments in the function of the Commission growing out of its extended program. These

in Sedona, Arizona, where I have been invited to serve the First Baptist Church in my retired position.

Before these plans were made for the move to Sedona, I asked the Executive Committee of the Commission to appoint a committee representing the Commission to advise with me and the Commission on my retirement. This was on October 5, 1959. I told the Executive Committee and the members of the Program Study Committee at that time that I was going to the California and Arizona Conventions in November and that several inquiries had come for my services after my retirement. I told them if an opportunity for service in my retirement should come from any of these inquiries, that I would seriously consider its acceptance.

As soon as I was led to the decision to move to Sedona, I wrote each member of the special committee appointed on October 5 to advise with me and the Commission on my retirement. In this letter I told the committee that I would like to make this move to Sedona by January 31, 1960; but that if they felt my services with the Commission should be retained through February, 1960, I was sure it could be arranged.


To Marry

Miss Nisbet has also been an able assistant in the research function of the Commission.. Many of the requests for information that come to this agency have been answered from her studies and research. She has had charge of the annual literature displays at the Southern Baptist Convention and at Student Week at Ridgecrest and Glorieta. Still another phase of her work has been that of bookkeeper for the Commission.
