Efforts have been made in this respect but they have failed. The history of these efforts is familiar and need not be repeated here. In 1875 this Association requested Dr. J. E. Hays to write the work of preparing such a history so would accomplish the desired object. We learn from him that he entered upon the work at once, but through the pressing invitations of churches to hold meetings with them, he for a time ceased to write. By adding health he was enabled to visit preaching and again he began to write. Having finished his introduction, he says: "I found it had needed to be written in a readable volume, such as large for an introduction." He has now completed the history proper and has written 272 pages. It is a volume extending from the settlement of the State till about the year 1778. It is one of these times we can only avail ourselves of the opportunity to say to him in making the work as complete as possible by furnishing him with facts, incidents, &c., coming under our notice. Dr. James P. Boyce, President of the Seminary (and also President of the Convention), stated that a promising emergency was now upon the Seminary, which he wished to bring to the attention of the denomination.
