We think far too little, brothers, of the great promise of a future life. To Jesus Christ, and to him alone, I believe, do we owe the certainty of anything beyond the present.

They tell us that Christianity makes too much of another world. I would Christians made more of it. Our faith is not in our present life, but in our future life.

So I ask you to turn to these great words of the Master's, and try to think of them with me this morning. I suppose the more you think of them, the better you shall know their greatness.

Now, with regard to the first of these points, the victor's reward, I would point out that there are two lines of thought in the great words, which perhaps it may conduce to clearness if we look at them separately. There is the substance, and there is the form.

As for the substance, it is simply that wide, all-comprehensive, and in every respect greater, than the promise of life. Now, it is to be remembered that, if there is anything characteristic of John's writings, it is his emphasis and his language, which is great and to be admired. It is a great deal more than bare existence. It does not simply mean that we shall be happy, but that we shall be glorified. But it always carries with it, connotes, other ideas, without which Scripture, and especially his writings would be incomplete. But the life which Jesus Christ thought worth calling by that name meant not only being well-being, but also being glorified, that the perfection of being. And the text is not merely an assurance that, beyond that apparent close of everything, there shall be a further continuance of unending existence, but that in the life of the future, we shall be able to possess, and the entire and complete of everything that we desire, and the bliss of the life and the light possessed.
