## Mission giving passes goal at mid-year

At the midway point of the budget year for the Tennessee Baptist Convention, mission gifts through the Cooperative Program are running ahead of the basic budget-goal, according to Tom Madden, TBC executive secretary-treasurer.

Messengers to the 1982 state convention approved an \$18-million Cooperative Program budget-goal for the November 1982-October 1983 convention year — divided into a \$16.8-million basic budget section and a \$1.2-million Bold Mission Thrust challenge section.

Cooperative Program gifts for the first six months of the convention year (November 1982-April 1983) were \$8,541,468.73 when the books closed April 29, Madden reported. This amount is 1.7 percent

above (\$141,468.73 above) the six-month basic budget-goal of \$8.4-million.

Obviously pleased with the mid-year total, Madden said this is a solid indication of "the mission spirit across Tennessee."

This is the first time since 1980 that mission gifts through the Cooperative Program were ahead of the basic budget-goal at mid-year.

Madden further noted that the \$8,541,468.73 shared by Tennessee churches through the Cooperative Program is 9.89 percent higher than the \$7,772,355.40 given during the November 1981-April 1982 period. This is an actual increase of \$769,113.33.

The TBC executive secretary reported

that April's mission gifts through the Cooperative Program were \$1,438,636.02 — which was 2 percent higher than the \$1,411,107.28 given during April 1982.

The monthly basic budget-goal for the current convention year is \$1.4-million (one-twelfth of \$16.8-million). April's Cooperative Program gifts were 2.8 percent higher than the monthly goal.

Madden observed that Tennessee Baptists have exceeded the \$1.4-million monthly basic budget-goal in five of the six months of the current convention year.

In his mid-year report, Madden added that Tennessee Baptists are also making significant increases in designated offerings.

He noted that \$3,574,041.86 had been given since November to the Lottie Moon Christmas Offering for Foreign Missions. This is a 9.1 percent increase over the \$3,275,828.74 given at this time last year.

In addition, during this same period \$871,070.12 has been shared by Tennesseans with the Annie Armstrong Easter Offering for Home Missions — which is a 21 percent gain over the \$718,901.45 given at this time last year.

## FMB elects Paraguayan to church growth post

RICHMOND, Va. (BP) — A Paraguayan pastor and convention leader will become Latin America consultant for evangelism and church growth upon retirement of the Southern Baptist missionary now serving this area.

Jose Missena, pastor of Villa Mora Baptist Church in Asuncion, Paraguay, and executive secretary of the Latin America Baptist Union, began work May 1 as consultant-elect. He will be the first Baptist national related to Southern Baptist work overseas named to such a post.

Missena will assume full responsibility Jan. 1 after retirement of Missionary Roy L. Lyon, regional evangelism and church growth consultant since November 1980.

Charles Bryan, head of overseas operations for the Southern Baptist Foreign Mission Board, said Missena will be a part of the Latin America field staff and his work will be coordinated by the three Latin America area directors.

He will continue to live in Asuncion but will be available to travel throughout Latin America as he assists both missionaries and national bodies in evangelism planning and encouragement of church growth.

Missena will relate on a fraternal basis with the three missionaries who fill evangelism and church growth posts in other parts of the world. Bryan said when he met with area directors for Middle America and the Caribbean, eastern South America, and western South America to discuss a successor to Lyon, they decided it was the right time for a national to provide these consultant services.

From a number of capable Latin leaders, they settled upon Missena because of his experience in church development, his widespread use as an evangelist in other countries of the region, and his ability to inspire and encourage others.

For more than 24 years Missena has

been pastor of the influential Villa Mora church, but he had recently shared with his congregation he felt God was leading him into other areas of evangelism at the end of his 25th year there.

Missena is a native of Paraguay, a Spanish-speaking country, but is fluent in Portuguese and has a working knowledge of English. A graduate of the International Baptist Theological Seminary in Buenos Aires, Argentina, he has served both as president and executive secretary of the Evangelical Baptist Convention of Paraguay and as a board member for Baptist Hospital, Asuncion.

As executive head of the Latin America Baptist Union, he represents his region in relating to the Baptist World Alliance. His wife, Betty, a native of Uruguay, manages the Baptist bookstore in Asuncion and also served at one time as president of the Paraguay convention. The Missenas have three grown children.

## Mother's Day offering set for May 8

Next Sunday, May 8, members of Tennessee Baptist churches will again share directly in the child care ministry of the Tennessee Baptist Convention through the annual Mother's Day Offering for the Children's Homes.

The theme for this year's observance is "God's Child... Our Gift." The goal for the 1983 child care offering is \$600,000, which will provide almost one-third of the operating budget for the Tennessee Baptist Children's Homes, according to Evans B. Bowen, TBCH executive director. The remainder comes through the Cooperative Program or from direct gifts from individuals and churches.

Under the direction of a Board of Trustees elected by the state convention, Tennessee Baptists operate four homes in Chattanooga, Memphis, and Franklin and a satellite home in Johnson City.

During 1982, TBCH ministered to 561



children and their families through its multiple services. Among services offered are group care, foster home care, adoption, mother's aid, counseling, continuing education, and maternity care.

According to Bowen, the purpose of these ministries is redemptive, seeking to restore the child's faith in himself, in others, and primarily in God and to lead the child to faith in Jesus Christ as Saviour and Lord.

TBCH has mailed special promotional materials, including bulletin covers, to all Tennessee Baptist churches for use on May 8.

Tennessee Baptists' first venture into child care came in 1891 when the first home was opened in Nashville.

The annual child care offering was started in 1961 and during the first two years was received at Thanksgiving. Since 1963 the special offering has been given on Mother's Day.

## Leawood to host movie premiere

# Broadcast conference explores opportunities

ATLANTA (BP)— When Southern Baptists enter the big leagues of telecommunications next year, they will be greeted by an unparalleled opportunity for evangelism, missions, and education.

That was the opinion of speakers at the National Conference on Broadcast Ministries. The third annual conference was the last before the launch next spring of the American Christian Network and Baptist TelNet, Southern Baptists' two satellite networks.

Participants heard Jimmy R. Allen, president of the Radio and Television Commission; Grady C. Cothen, president of the Baptist Sunday School Board; Russell Dilday Jr., president of Southwestern Baptist Theological Seminary; and William G. Tanner, president of the Home Mission Board, analyze the impact of ACTS and TelNet on their ministries and on the churches they serve.

Allen said ACTS, the over-the-air TV network his agency is designing, will permit local churches to provide the "true localism" intended but never attained by television and cable TV. He said the effort would be "high touch as well as high tech."

Quoting John Nesbitt, author of *Megatrends*, Allen said Southern Baptists are the only major denomination in a position to take advantage of new television technology.

Cothen said the Sunday School Board is planning Baptist TelNet as an internal communications network in churches, and is not interested in establishing an electronic denomination, but in undergirding churches.

"This is not a new program," he said of the TelNet effort, "but a new methodology to help you. Its purpose is to focus on the needs of churches, not to bypass churches."

The telecommunications ministries of Southern Baptists will impact their seminaries in at least two ways, Dilday said. Curriculum content will be broadened to include technical and theological training of ministers of media for work in SBC churches, he said. While there are already 50 full-time media ministers in Southern Baptist churches, Dilday pre-

dicted there will be 500 in the next five years. He noted Southwestern seminary has established the Center for Christian Communication Studies to provide this training.

Teaching methodologies also will be affected, Dilday said. He indicated the seminaries already are teaching extension courses through use of video and teleconference.

Tanner said the ACTS network will be particularly helpful to the Home Mission Board in reaching America's large cities, where Southern Baptists are often not well known. ACTS will give Baptists instant access to millions of homes and complete coverage of metropolitan areas.

"The reason we are dying in cities is because we are not getting the priority prospects," he said. "What we need is presence. The most evangelistic denomination on the face of the earth is Southern Baptists. And if we ever get that presence we can reach the megacities."

Five hundred people participated in the three-day training meeting, sponsored by the RTVC, Sunday School Board, and Southwestern seminary. It is considered the second largest annual gathering of Christians involved in broadcast ministries, surpassed only by the interdenominational National Religious Broadcasters.

The conference, held the past two years in Ft. Worth, was moved to Atlanta to allow more participation from the Southeast, a strategy organizers said proved successful.

In speeches, discussions, workshops, and technical displays, the conference concentrated on equipping churches to plug into ACTS and TelNet. Twenty-three workshops instructed media workers on ways to get ACTS into their communities, uses for TelNet in churches, and production techniques for local programs.

One Southern Baptist media effort already in place, the Video Tape Service, also was showcased. Coordinator Doug Day said VTS will fill in the gap when TelNet is not feasible for some churches, by providing teaching, training, and inspirational video tapes through state conventions.

## Church history workshops set

Two church history workshops have been scheduled for next week. South Knoxville Baptist Church, Knoxville, will host a workshop May 9 from 7 to 9:30 p.m., and the other will meet at the Tennessee Baptist Convention building May 10 from 7 to 9:30 p.m.

Charles Deweese, director of editorial services for the Southern Baptist Historical Commission, will help lead both workshops.

Glenn Toomey, director of missions for the Nolachucky Baptist Association and president of the east Tennessee chapter of the Tennessee Baptist Historical Society, will assist with the Knoxville workshop. Fred Rolater, professor of history at Middle Tennessee State University, Murfreesboro, and president of the Tennessee Baptist Historical

Society, will help lead the Brentwood workshop.

Church staff members, church clerks, church librarians, history committee members, and others interested in preserving Baptist history are invited to attend.

The workshops, sponsored by the Tennessee Baptist Historical Society, will probe the significance of a church's history; how to collect, preserve, and house historical materials; and how to write a church or associational history.

A workshop fee of \$3 will include registration, the workshop, refreshments, and all related materials, according to Eleanor Yarborough, Historical Society consultant for the Tennessee Baptist Convention.

## Moody claims ACTS launch holds historical importance

ATLANTA (BP)— Next year's launch of the American Christian Television System Network (ACTS) is as important to Southern Baptists as the birth of the Cooperative Program in 1925, California Pastor Jess Moody told the National Conference on Broadcast Ministries.

"We must make up our minds to prioritize the ACTS network," he said. Moody, pastor of the 12,000-member First Baptist Church of Van Nuys, delivered the keynote address of the three-day training meeting, attended by 500 Baptist media workers.

"I really don't want us to think of this as just another Baptist meeting," Moody said of the third annual broadcasting conference, the last before the launch of ACTS, Southern Baptist's national TV network. "This is an historic moment, a moment as freighted with importance as the birth of the Cooperative Program."

Moody said television has become the scene of a fierce struggle for control of human lives. "The battle for the whole world is not a battle for borders. It is a battle for the human mind. What captures the eye conquers the world."

Southern Baptists are retooling to meet the modern challenge, Moody said, through their three telecommunications efforts — ACTS, Baptist TelNet, and the Video Tape Service. "Baptists, it is your turn to knock at the nation's door," he said. "This nation is interested because it has run out of options."

"ACTS has come upon the scene at a time when Hollywood has fornicated its brains out and attacked marriage until it seems the wedding band is second only to herpes on a secular list of woes," Moody said Christians must share the blame for the faults of the entertainment business because they have remained silent.

"Christians fled from the arena and left it to the lions 50 years ago. Don't blame Hollywood because it went bad. It all went bad because we pulled up the righteous skirts and ran away in Phari-

saic horror the first time Jean Harlow showed her calf."

Baptists are back in the arena in a big way, Moody said, and their telecommunications will succeed because they tie modern technology to a life-changing message.

"There isn't a sociologist or futurist who will tell you Southern Baptists are making a mistake," he said. "We have grown because we have not flinched before some radical adaptation that was keyed to evangelism and missions."

"God will give it to us because we are challenging every wealthy, every middle class, and every poor, dead-broke Baptist to do that which can change the nation. It is a challenge that stirs the blood, imagination, and enthusiasm of Baptists."

"We must make it possible for every Baptist to give to this because it is not a standard-brand church cause. It is the absolute, pitched battle for the soul of America."

"I just pray that every seminary, every agency, board, committee, every Southern Baptist will realize we must somehow find a way, the mega-money, the heart to make this thing happen."

Moody said other television ministries are ill-fated because they are tied to personalities. ACTS will outlive them all, he said, because its strength rises from local churches.

### Charles Hicks moves to Park City pulpit

Park City Baptist Church, Fayetteville, called Charles R. Hicks as pastor, a ministry he began April 10.

Hicks came to the church from the pastorate of Beech Bluff Baptist Church, Beech Bluff, and is a former pastor of Fruitland Baptist Church, Humboldt.

A native of Madison, Hicks is a graduate of Union University, Jackson, and Southern Baptist Theological Seminary, Louisville, Ky.

# Brotherhood dedicates new conference center

MEMPHIS (BP)— Speaking in the Brotherhood Commission's recently completed Glendon McCullough Conference Center, President James H. Smith opened the commission's spring trustee meeting calling for new goals in enrollment, curriculum, and training.

During the three-day, semi-annual meeting, the conference center was dedicated to Smith's predecessor, Glendon McCullough, a 1983-84 budget was okayed, and the formation and by-laws of a Fellowship of Baptist Men was approved.

Praising McCullough for his vision of a national center where men could be trained in missions, Smith said, "We will now be able to more effectively work toward our goals in training by developing the skills of church, associational, state, and SBC Brotherhood leaders.

Construction of the center and other refurbishing of the commission's Memphis headquarters, where the center is located, totaling more than \$300,000, will be completed without incurring any indebtedness.

An overflow audience packed the conference center for dedication services. Personalities from all segments of Southern Baptist life, including McCullough's widow, Marjorie; M. Wendell Belew of the Home Mission Board; John

Dunaway of the SBC Executive Committee; and June Whitlow of the Woman's Missionary Union participated in the dedication.

A recurring theme in many of the

dedication speeches told of the people whom McCullough touched through his life and work. Belew said his life had been touched in many ways during his long association with McCullough, but was particularly touched through McCullough's vision, humor, and dedication to missions.

"His children in missions, who grew up under him, are everywhere," said Belew. "Because of them, Glendon was

truly a man of the world through lives of people he touched."

Dunaway added, "While we are dedicating the Glendon McCullough Conference Center there's a very real sense in which we are dedicating ourselves and the Brotherhood Commission to the task of involving men and boys in missions."

In other business, the commission approved the by-laws of the Fellowship of Baptist Men which will function as part of the Brotherhood Commission. The fellowship will elect its own officers and will work to identify avenues of missions involvement for laymen.

The fellowship is a result of several years' study of the Brotherhood Commission on how to involve more laymen in SBC activities. The study was initiated by a group of laymen who felt laymen were not as involved in SBC life as they could be. The fellowship will attempt to complement, not duplicate, present Baptist Men's work while encouraging laymen to become more involved in missions.

The trustees also approved a \$2.6-million budget for 1983-84 and heard an update on the Brotherhood Commission's effort to enlist laymen to participate in an evangelistic crusade planned for Pennsylvania prior to the SBC annual meeting in Pittsburgh.

Douglas Beggs, director of Baptist Men and coordinator for enlisting crusade volunteers, reported 28 teams of 40 volunteers already have been formed. He said 10 additional team leaders have been enlisted and efforts are continuing to enlist more volunteers.

## Pollard cites integrity as biggest SBC problem

NEW ORLEANS (BP)— Frank Pollard, president of the Golden Gate Baptist Theological Seminary, Mill Valley, Calif., says one of the biggest problems for Southern Baptists today is not inerrancy, but integrity.

Speaking to a chapel audience at New Orleans Baptist Theological Seminary, Pollard said Southern Baptists are in danger of being permanently divided. "Sadly it cannot be said of us what the Word declares about the church in Acts: 'And the congregation of those who believed were of one heart and soul....'"

Calling himself a fundamentalist, "if you don't capitalize the word and put the accent on the second syllable," Pollard said he had no problem declaring the Bible inerrant, infallible, and inspired. "When any Baptist institution causes young minds to doubt the Word of God, I believe it to be a tragedy which must be corrected," Pollard said.

He added: "Like many of you I cannot side with the few who do not share those convictions about the Bible. Another great agony is that we cannot side with many who are calling themselves 'inerrantists'. In fact I do not believe inerrancy is all of the issue in our current division. A large part of the issue is integrity."

Implying the integrity problem involves the spread of innuendo and false information, Pollard told of a Southern Baptist church that was providing extensive support for a non-Southern Baptist Convention seminary. The reason given was, "The Bible is not being taught in any of our seminaries."

On the basis of accusations made by one of the members of that church, Pollard scheduled conferences with two of his former professors who were named as teaching specific heresies. The member leveling the charges would not accompany Pollard to confer with the professors in question.

Pollard learned that "the charges were untrue. What's more, no one had talked to them about these things." He continued, "When I told that New Testament professor someone had said he (the professor) didn't believe in the virgin birth, he shook his head and cried."

Pollard added, "I fear there has been too much of this kind of slander. Broad, general statements may sometimes contain a half truth, but if they are half true they are also half false." He said there are several steps a Christian must take before he is Biblically free to go public with a complaint. "If you really believe the Bible to be God's word, you need to know it forbids you to slander anyone," Pollard said.

Pollard concluded, "Liberalism can kill a church or a denomination, but, an even greater warning for us is that a judgmental, negative spirit can kill a church or denomination, also."

## Eighteen leave for Upper Volta to aid hunger relief project

Eighteen more volunteers left Tennessee April 30 for Upper Volta to participate in the hunger and relief effort in that western African country in a joint project of the Tennessee Baptist Convention and the Southern Baptist Foreign Mission Board.

Tennessee is in the third year of a five-year project to assist in agricultural, medical, literacy, evangelistic, and water conservation projects.

## Baptists aid embassy victims

BEIRUT, Lebanon (BP)— Steve and Meriam Fox, Southern Baptist extended service volunteers to Lebanon, are helping victims of the April 18 bombing attack on the American Embassy in Beirut.

Less than an hour after the explosion, which killed at least 60 and injured more than 100 persons, the Foxes received a call from a man in Philadelphia asking the Kettering, Ohio, couple to check on his son's safety.

The Foxes went immediately to the American University Hospital, where Mrs. Fox does volunteer work every Tuesday. Within three hours they were able to tell the anxious father that his son was seriously injured but would survive.

Mrs. Fox offered to arrange round-the-clock assistance in the rooms of injured Americans, since most of them had no family members to be with them. Hospitals in the Middle East assume family members will be present with seriously ill patients.

She enlisted the aid of other members of the American Women's Club to help her sit with patients who needed to be watched. Some not only were injured physically but experienced grief or emotional shock because they lost spouses in the blast.

# FMB official analyzes rejection of permits

AMMAN, Jordan (BP)— Jordan has denied residence permits for three Southern Baptist missionaries, but one couple may be allowed to return, according to a Southern Baptist Foreign Mission Board official.

Isam Ballenger, director of Southern Baptist work in Europe and the Middle East, said it is still impossible to determine why Jordan revoked the residence permits of two missionaries and denied a permit for a third in March.

Jordanian officials revoked the permits of Missionary Nurse Ruth Ann McConnell of Kentucky and Missionary Pharmacist Gary Tapp of Georgia. Tapp's wife, Judy, also was denied a permit.

Ballenger said it would be "premature and perhaps misdirected" to assume that the Jordan actions came in response to articles in a Jordan newspaper quoting pro-Israel statements made by New Right religious leaders in the United States.

Soon after the articles appeared, Tapp

went to government officials to seek a residence permit for his wife, Judy. The officials refused to grant it and revoked permits already granted to Tapp and McConnell.

Since then Jordan has granted entry to a new missionary teacher, Gerry Volkart of Missouri, for the Baptist school in Amman.

The Tapps have been waiting in Cyprus with their two small children while new efforts are being made to obtain the necessary residence permits to re-enter Jordan. McConnell, a registered

nurse, is working at the Baptist Hospital in Jibla, Yemen.

Ballenger said he would not be surprised if there were actions against mission work and missionaries in Arab countries because of such pro-Israel statements. But he said he did not want to second-guess the governments of these Arab countries or make any such interpretation "without clear and sufficient knowledge."

He said these countries have certain laws and procedures they follow in matters of entry, and added that "we cannot

always understand the reason why certain actions are taken."

But he does believe there is a fair chance the Tapps will be allowed to return. Southern Baptists have 36 missionaries assigned to Jordan, where the denomination has had work for more than 30 years.

As in a number of other countries, residence permits are not always granted. A young doctor, Dan Baker, was refused a permit by Jordan last year and now is doing his one-year of special project service in Yemen.

Last year's Southern Baptist Convention, an effort was made to pass a pro-Israel resolution, but R. Keith Parks, president of the Foreign Mission Board, led a successful fight that resulted in the action being tabled.

When announcement was made in February that the resolution would be introduced again this year, Parks issued a strong statement saying such action would hinder mission work both in the Middle East and other parts of the world where missionaries work in pro-Arab countries.

## New Orleans seminary initiates degree programs in night school

NEW ORLEANS (BP)— For the first time, a student can earn a degree by attending night school at New Orleans Baptist Theological Seminary.

The master of divinity, master of religious education, or associate of divinity degree can be earned in the same amount of time that it would take a student attending day classes to earn the same degree, said Joe Cothen, vice-president for academic affairs. In addition, no day classes are necessary to complete requirements.

The program has been in effect for 10 weeks, and the response has been "excellent," Cothen added. One hundred thirty-two students enrolled in the first eight-week term and 178 enrolled for the second term.

"It has become apparent students are experiencing more and more difficulty in being able to make a living by working nights and part time during the day. And

it was virtually impossible for student wives who had to work to get any seminary training," Cothen observed, adding, these were two reasons for initiating evening classes.

According to Cothen the program calls for the participation of the entire faculty with each member scheduled to teach at least one evening course per year. At a recent annual board of trustees meeting an 18 percent base salary increase was granted to the entire faculty to compensate for the extra teaching load.

At that trustee meeting, approval was granted for students to audit seminary courses and a special "short form" registration procedure was adopted. This will make it easier for layworkers to enroll in classes.

Eight courses were taught during the first eight-week term and 10 are being taught during the second term of the "second track" program. The courses range from undergraduate level courses on religion in society in English and Spanish, to masters level courses on the doctrine of the Holy Spirit or contemporary approaches to religious education.

Plans for a full night program have been in the process for over a year, said Landrum Leavell, seminary president. A survey was made among laypersons and pastors in the community and among students. The faculty gave full cooperation and have been "enthusiastic," according to Leavell.

## Eldad calls Campbell to first pastorate

Kelly Campbell began duties in his first pastorate recently, in response to a call from Eldad Baptist Church, Trenton.

Campbell came to the church from Bethel Baptist Church, Greenfield, where he was associate pastor and minister of youth. He was previously minister of youth at Natchez Trace Baptist Church, Camden.

Campbell was ordained into the ministry March 27 by First Baptist Church, Greenfield, where Dan G. Farmer is pastor.

A native of Greenfield, Campbell is a graduate of Union University, Jackson.

## McEwen leaves SBTS for Chattanooga post

LOUISVILLE, Ky. (BP)— Jack H. McEwen has resigned as dean of the school of religious education and as professor of religious education at Southern Baptist Theological Seminary in Louisville, Ky., effective July 31, 1983.

He will become professor of psychology and director of community development at Chattanooga State Technical Community College, Chattanooga.

McEwen came to Southern three years ago from First Baptist Church, Chattanooga, where he had been senior minister for seven years. He had previously been pastor of First Baptist Church, Daisy; Northside Baptist Church, Chattanooga; and two churches in Texas.

From 1966-73, he held various positions at the University of Tennessee at Chattanooga, including assistant professor of education and psychology and also dean of students.

He is a graduate of the University of Tennessee, Knoxville; the University of Chattanooga; Southwestern Baptist Theological Seminary, Fort Worth, Tex.; and Baptist Bible College, Springfield, Mo., and has studied at Baylor University and the University of Colorado.

In his letter of resignation to seminary President Roy L. Honeycutt, McEwen said the decision to leave Southern and to go to another position was not easily made. However, the challenges provided by Chattanooga State Technical Community College and the opportunity to return to the Chattanooga area attracted him.

## Joan Wolfe succumbs

Joan Wolfe, adjudicator for many Tennessee Baptist music festivals and a former junior high music teacher, died April 21 after a lengthy illness.

The 23rd Psalm puts great emphasis upon the attentive care which shepherds exercise for their sheep.

This might be summed up by the statement, "Surely goodness and mercy shall follow me all the days of my life."

The sheep know that goodness and mercy will be a part of the treatment they will always receive from their shepherd.

You and I can transfer this into our Christian lives. However, an honest question may be asked. How many of us truly believe that no matter what occurs in our lives, we are being followed by goodness and mercy?

This is the supreme portrait of our Lord. There continually flows out to us His goodness and His mercy. Even when we do not deserve them, His goodness and mercy come unremittingly from their source of supply, His own great heart of love.

However, there is another aspect to this statement that I would like to emphasize. Just as our Lord's goodness and mercy flow to us all the days of our lives, so should goodness and mercy follow us and be left behind us, wherever we go.

Sheep can ruin and ravage the land beyond remedy. In contrast to this they can be the most beneficial of all livestock, if properly managed. I read in some literature where sheep were referred to as "those of the golden hooves" simply because of their beneficial effect on the land. When properly shepherded, sheep can change land which is almost derelict and useless into beautiful almost park-like properties of immense worth. Another way to put it is, goodness and mercy can follow the flocks.

### Citizen's Corner

The pari-mutuel gambling issue has been delayed for Tennessee, but it is certainly not dead. Last week the Senate and local government committee voted to defer the racetrack gambling bills to January of 1984.

Comments made during that committee action and later in the press call for some response.

For instance, some people seem to feel that the bill will pass "one of these days." It is not inevitable that we will have racetrack gambling in Tennessee. It is reasonable to suppose that there will always be someone pushing for a gambling law, but as long as good sense prevails, Tennesseans can do without racetrack gambling.

At the committee meeting it was stated that the bill should be delayed for a year so that there could be sufficient study to come up with a bill that is airtight. There are two problems with that statement. In the first place, the bill was put off because the sponsor only had three votes when he needed five to pass it out of committee. Second, there is no airtight amendment that can be added to the bill that will guarantee that gambling in Tennessee will be crime free.

One senator observed that most Tennesseans want racetrack gambling, but they do not understand what is in the bill that the General Assembly was facing. Concerned citizens now have the opportunity to help see that Tennesseans learn just what racetrack gambling is all about.

A footnote to the racing question: The issue is pari-mutuel gambling not horse racing. If you are interested in horse racing, come to Nashville next week and attend the Iroquois.

### Hopewell church calls Meredith as pastor

Hopewell Baptist Church, Lavinia, recently called Michael Meredith as pastor.

Meredith, who began the position April 3, is a student at Union University.

### BSSB votes funds for Telnet uplink

NASHVILLE (BP) — Funds for a Baptist TelNet uplink and preparation of a site near downtown Nashville were approved April 28 by the executive committee of the Baptist Sunday School Board's trustees.

When the satellite network to churches becomes operational in mid-1984, the uplink will transmit the Baptist TelNet signal to the Spacenet I satellite which will retransmit the signal to receiving earth stations.

The uplink will be purchased from Scientific Atlanta which submitted the lower of two bids received. The uplink will cost approximately \$435,000.

Planning and site preparation, which include an access road, equipment building, foundation, microwave tower, and fencing, are expected to cost \$145,000.

The uplink will be located on property owned by the board on Thompson Lane, three miles south of downtown Nashville. Site preparation will begin immediately with installation of the uplink due to be completed early in 1984.

### Helms retreats from amendments

WASHINGTON (BP) — Citing certain "assurances from the White House," Sen. Jesse Helms backed away from offering a series of federal court jurisdiction amendments to bankruptcy legislation passed by the Senate April 27.

The North Carolina Republican had announced earlier he would offer amendments limiting federal court jurisdiction and providing for congressional review of federal judges. Among them were amendments to remove Supreme Court and lower federal court jurisdiction in school prayer cases and to limit federal court authority to enforce school busing actions.

Other than a letter from President Reagan expressing administration concerns about reducing federal court jurisdiction, Helms did not spell out what specific White House assurances led to his decision not to call up the amendments. He advised his colleagues, however, they "undoubtedly will come before the Senate another day."

# Solomon and the covenant

Basic Passage: 1 Kings 9:1 to 10:29 (2 Chronicles 7:11 to 9:28)  
Focal Passages: 1 Kings 9:3-5a, 17-21, 26; 10:1, 22-24

The opening of chapter nine marked another of the Lord's appearances to Solomon. At this time Israel was in her zenith. The Temple and the palace complex were completed. National prestige reached new heights. Jerusalem and Solomon's court were building international reputation.

Yet this week's passage (chapters 9-10) signals crisis. Someone wisely said that individuals and society experience similar changes: birth, infancy, childhood, adolescence, robust adulthood, deterioration, and old age. At this point in Israel's history and development, she was facing a turning point.

The drive that thrust Israel into international prominence finished the magnificent work on the Temple and the palace. Now it was in danger of becoming inert. The goal had been completed and as yet Solomon had not given them another.

**Conditional covenant (9:3-5a)**

The Lord's second appearance was with promise, encouragement, and warning. He acknowledged the king's faithfulness and reiterated His presence ("My heart shall be there perpetually") in the Temple.

He promised Solomon that the throne would continue, but the fulfillment of that promise was conditional. The condition was Solomon's faithfulness ("— if thou wilt walk before Me — in integrity — in uprightness — and do all I have commanded thee — and keep My statutes").

If the covenant was kept, God promised "to establish" the throne upon Israel forever. Verse seven warns that God promised to accomplish if they turned their backs on Him.

**Conscripted construction (9:17-21)**

In verses 15-28 we see the extent of Solomon's building enterprise. This record verifies he used slave labor (v.15). Such was a common practice of the time, but it was a practice never approved by God.

Verses 17-18 listed cities Solomon built or rebuilt for his strategically-placed fortresses. One of these cities, Gezer, had been a part of the dowry given by the Egyptian pharaoh for Solomon's wife.

In verses 19-21 the writer listed some

necessary uses of the fortress cities. They include warehouses (cities of storage), armories (cities for his chariots), and barracks (cities for his horsemen).

No Israelite worked in forced labor, however they did serve in Solomon's army.

**Commerce created (9:26)**

Solomon created a merchant fleet to conduct trading activities for him in foreign ports. Evidently this met with the success of which Solomon had grown accustomed. Verse 28 tells us they brought him 420 talents of gold on their maiden voyage. If we figured this in today's currency it would exceed \$10-million.

**Celebrity captivated (10:1)**

Solomon's navy operated along the Arabian coast. It was natural that his reputation reached the Queen of Sheba, the land now called Yemen.

It is reasonable that her visit also included time to discuss political alliances between their countries.

The queen's coming to "prove" Solomon with hard questions was a battle of wits. At the end, the queen praised Solomon's God and returned to her country to give great praise for the magnificence of Solomon and his court.

Yet verse 13 records that Solomon gave her all she desired. They exchanged the normal diplomatic gifts, but Solomon did more.

**Cycle continued (10:22-24)**

The two areas of Solomon's reputation, wealth and wisdom, continued to build. Yet in the closing half of chapter 10 extravagance becomes an added trait.

The more Solomon spent, the more revenue he needed to gather.

Verse 23 pictured Solomon as the richest king. God gave him riches when he only requested wisdom. Now his priorities were sorely misplaced and he was even importing exotic pets. The fall of Solomon was beginning.

**Conclusion**

God truly blessed the rule of Solomon. He kept His word to the king. Yet there is a lesson in this account for us in that followers of God should never take our spiritual relationship for granted. Knowing and keeping His commandments is always important. As we balance our priorities, we must always examine our lifestyle to determine what God wants in our lives.

# Conflict in Corinth

Basic Passage: Acts 18  
Focal Passages: Acts 18:1, 4-17

**On to Corinth**

In previous lessons it has been noted that on Paul's second journey, he passed through Asia Minor to Troas and from there sailed to Philippi.

Leaving Philippi, he traveled the Egnatian Way west to Thessalonica, the capital of the province of Macedonia. He worked there until an uproar among the Jews caused him to leave.

Then he went to Berea. His work was well received here until Jews from Thessalonica followed him and caused a tumult among the people.

Paul then moved on to Athens, in the Roman province of Achaia, the intellectual and artistic capital of the world. Paul preached in this sophisticated city with some unusual success but was also mocked for his unsophisticated gospel of Jesus and the resurrection.

He voluntarily left Athens and moved on to Corinth to continue his ministry. Corinth was the capital of the province of Achaia and thus the place of residence of the Roman governor. It was a great cosmopolitan city, the melting pot of the east, famed for its commerce and its religious immorality and sensualism.

Destroyed by the Romans in 146 B.C., it had been restored by the Romans as a colony 100 years later and had become an important commercial city with two seaports. Such a city attracted all peoples and, therefore, had a significant Jewish population.

**New missionary associates**

Paul had begun his journey with Silas, took Timothy as a companion in Lystra, and had Luke as a companion for a short time. At Corinth, he came in contact with two new associates.

Aquila and Priscilla were Jews who had recently come to Corinth from Rome. According to Roman historians an edict expelling Jews from Rome came in the ninth year of Claudius, A.D. 49, and thus gives us a significant chronological point on Paul. The expulsion was for tumults arising among the Jews over one "Chrestus," which probably was a corrupted spelling for Christus, the Romanized name of Jesus.

Aquila and Priscilla may have been Christians before they left Rome. Therefore, this may account for their early

association with Paul. Another common interest which caused them to be associated was a similar trade, that of tentmaking.

**New direction for ministry**

Paul began his work in Corinth in the common pattern by which he had worked in every city — he started in the synagogue. It was a natural place to begin his work for there were people there who would have a background to understand his message. He had normally worked in the synagogue until he was driven out and then went to Gentiles.

In Corinth, Paul gave a new twist to his work — he left the synagogue before he was forced to leave and went to the Gentiles. This new direction for his ministry must have caused him some concern, for Paul was reinforced by a vision from God which gave him assurance of God's strength and protection.

Paul's ministry in Corinth extended to one and one-half years and produced outstanding results. Even the ruler of the synagogue was converted and baptized along with many other Christians. A great church was established to which Paul wrote many letters and made additional visits.

**Paul before Gallio**

Luke noted that Gallio was proconsul (governor) of Achaia while Paul was in Corinth. Other historical sources indicate that Gallio apparently became governor in A.D. 51. This provides an additional chronological datum on Paul's life.

Paul was accused by the Jews before Gallio as a lawbreaker. Luke's major interest in this incident was in the fact that Paul, a spokesman for Christianity, was brought before an official of Rome who refused to even hear the case against him. It amounted not so much to an exoneration of Paul as an exoneration of the Christian gospel, which was later officially persecuted by the Roman state. It was Luke's way of showing an apology for this new religious belief in the Roman empire.

**On to Ephesus**

Paul's appearance before Gallio was probably near the end of his 18-month stay in Corinth. Shortly after this he, Priscilla, and Aquila sailed across the Mediterranean Sea to Ephesus.

Paul was a missionary strategist and his strategy was to plant the gospel in cities that were population centers. Ephesus was a great city from which the gospel would in time spread to the surrounding region.

This time he ministered only very briefly but left Priscilla and Aquila there and promised to return if God willed. Paul's companions enjoyed a ministry there while Paul went on to Caesarea, Jerusalem, and Antioch before setting his face back toward Ephesus.

## Historical Society meeting explores ethnic heritage

NASHVILLE (BP) — The 13.9-million-member Southern Baptist Convention was both praised and chided for its evangelizing methods among ethnics at the joint annual meeting of the Southern Baptist Historical Commission and Historical Society.

While Baptist witness and mission efforts among ethnics in the New World began as early as 1674 with attempts to "Christianize" Indians in the eastern colonies, the multi-ethnic denomination still has some things to learn about

relating to ethnic peoples in terms of missionary efforts and cooperation, participants were told.

At the same time, the ethnic experts noted the various successes of missionaries, pastors, and the SBC in general in reaching out to become the Christian melting pot it is today.

Oscar Romo, a Hispanic and director of language missions for the Southern Baptist Convention's Home Mission Board in Atlanta, quoted contemporary missiologist Peter Wagner: "Today

Southern Baptists are probably five to 10 years ahead of most other denominations in perceiving the true spiritual needs of Americans who are unmet."

Romo termed the growth of the ethnic/language-culture church in America as "phenomenal." Each week the SBC worships and works among 78 ethnic groups, 97 American Indian tribes, internationals, and deaf and hearing-impaired persons — a total of 81 distinct ethnic groups.

The language-ethnic leader estimated more than 300,000 people participate in the 4,000 ethnic/language-culture congregations of the SBC, but he also warned the denomination to "evangelize rather than 'Americanize'" in its efforts to minister to everyone.

The age of ethnics in the Christian church is here and churches that do not face up to it are going to face a "cultural collision," another Hispanic and SBC ethnic expert warned. The 1980s are the "decade of the Hispanics," and churches must face up to their needs along with that of other ethnics, said Joshua Grjalva of Mill Valley, Calif., national consultant of ethnic leadership development for the HMB.

Spotlighting 100 years of Hispanic Southern Baptists and their future, Grjalva noted the first organized Southern Baptist work among Hispanics was in 1861 when J. W. D. Creath was named missionary worker among the "Mexicans" in San Antonio, under the Baptist General Convention of Texas.

While Anglos were given credit for their share of the evangelizing and Christianizing of ethnics in the United States, Russell Begaye, a Navajo who is national consultant on Indian affairs for the denomination, reminded his listeners that ethnics have been active in winning their own people to Christ.

Southern Baptist ministry to American Indians is built on the lives of Indian believers, "many of whom died along the trails of persecution," he said. Several Indian preachers accompanied their people when the Cherokees traveled the

famous "Trail of Tears" in 1838, Begaye said, citing other numerous Indian preachers and missionaries who ministered to their own tribes and others.

The desire, Begaye said, for Indians to learn the "Christian way," prompted them early on to establish Christian schools for their own people.

While most Baptists in the country through 1845 (the year the SBC was organized) were interested mainly in pushing Indians out of the way, some white missionaries were the exception to the rule, said historian Robert Gardner of Shorter College in Rome, Ga.

He cited four early Baptist leaders who were prominent "because of their concern for Indians." The exception rather than the norm, they were David Jones, Peter Folger, Isaac Backus (probably the best known in Baptist history), and Peleg Burroughs.

In his research, Gardner said he discovered women endured the mission responsibilities to Indians better than men, and stayed on longer, in spite of hardships heaped on the females in western mission areas.

Southern Baptist work among the Chinese and other Asians in this country goes back to at least 1854 when J. Lewis Shuck established the first Asian Southern Baptist ministry in Sacramento, Calif. That same chapel produced the first Asian Southern Baptist lay preachers, Ah Mooyo and Ah Chak (Leong Chak), who aided Shuck, said Peter Kung, a Chinese Southern Baptist Asian expert who is a liaison between the denomination's Home Mission Board and Baptist Sunday School Board.

Cooperation and a positive attitude by Southern Baptists toward immigrants and non-Anglos has ensured continued work on a large scale with ethnic and minority groups in this country, according to SBC historian Lee N. Allen, dean of Howard College of Arts and Science at Samford University, Birmingham, Ala.

The theme of the historical meeting was "Ethnic Southern Baptist Heritage."

## Historical Commission sets budgets, okays floor plan

NASHVILLE (BP) — The Southern Baptist Historical Commission in its annual meeting approved the agency's floor plans for the proposed new Southern Baptist Convention building, adopted record budgets for 1983-84 and 1984-85, and elected new officers for the coming year.

Funding for the proposed 12,420-square-foot historical facility will total \$1.28-million, with \$382,000 designated for furnishings and equipment, if approved by messengers to the Southern Baptist Convention in June.

The record budgets for 1983-84 and 1984-85 total \$456,875 and \$681,560, respectively. Requested Cooperative Program allocations for those budgets are \$393,600 and \$603,360, respectively, subject to SBC messenger approval.

Wayne Flynt, chairman of the history department at Auburn (Ala.) University, is the newly-elected chairman of the commission. Stan Rushing, pastor of First Baptist Church, Newport, was elected vice-chairman; Stephen Carleton, vice-president and academic dean for California Baptist College in Riverside, Calif., secretary; and Lynn E. May Jr. of Nashville, treasurer.

On invitation of Woman's Missionary Union Executive Director Carolyn Weatherford, the new WMU headquarters, scheduled to open in 1984 in Birmingham, Ala., was approved as the site for the 1987 joint annual meeting of the Historical Commission and SBC Historical Society.

The theme adopted for the 1987 meeting, one year preceding the 100-year anniversary of WMU, is "Baptist Women in Southern Baptist History."

A seven-member committee was appointed to develop policies for the pro-

posed library and archives and to refine the floor plans for the commission's facility in the new SBC Building, on property adjacent to the Baptist Sunday School Board at the corners of Ninth and Commerce streets in Nashville.

The commission also honored two historians for their contributions to Southern Baptist history.

Leo Crismon, retired librarian at Southern Baptist Theological Seminary in Louisville, Ky., received the commission's Distinguished Service Award for Outstanding Contributions to Baptist History. The commission cited work as an "Eminent Seminary Librarian, early developer of the commission's library, noted collector of Baptist historical materials, facilitator of Baptist historical research, a prolific writer, committed supporter of state Baptist historical work, dedicated supporter of the commission, and life member of the Southern Baptist Historical Society."

The other honoree was Doyle Young, instructor in church history at Southwestern Baptist Theological Seminary in Fort Worth, who won the Norman W. Cox Award for his article, "Andrew Fuller and the Modern Mission Movement," which appeared in the commission's quarterly journal, *Baptist History and Heritage*.

At the luncheon, three Tennesseans were among the six commissioners who rotated off this year and were honored with plaques. The Tennesseans are Ethlene Rich and Fred Kendall of Nashville; and Don Whitehead of Maryville.

The April 23-25, 1984 joint annual meeting of the commission and the Historical Society will be in Nashville, on the theme, "The Role of the Bible in Baptist History."

## C-N grants honorary doctorates to graduates who were roommates

JEFFERSON CITY — Two 1931 Carson-Newman graduates, who were roommates in college, will receive honorary doctorate degrees from their alma mater at its May 6 commencement.

Lawrence D. Smith of Rutledge and Lawrence W. Trivette Sr. of Knoxville will be awarded the doctor of laws and doctor of divinity degrees, respectively, according to C-N President Cordell Maddox.

A native of Rutledge, Smith is also a graduate of Struby School of Pharmacy. He became registered as a pharmacist in 1932 and as a funeral director in 1940. He is the president of Smith Funeral Home and former president of Smith Drug Store.

In addition, he organized the Rutledge Volunteer Fire Department and served as mayor of Rutledge for eight years.

He has served as chairman of Carson-Newman's advisory board and as a trustee for 18 years.

Born in Butler, Trivette served as director of missions of the Knox County Baptist Association from 1944-72.

Following his graduation from Carson-Newman, Trivette was associate pastor of Central Baptist Church, Johnson City, from 1931-33. He attended Southwestern

# Sharing the good news

Basic Passage: Isaiah 49:1 to 52:12  
Focal Passages: Isaiah 49:4-8; 52:7-10

At the risk of oversimplification, Isaiah 40-48 may be considered as dealing mainly with God's redemptive purpose while Isaiah 49-55 emphasizes His redemptive message.

A proper proclaiming of the latter requires an understanding of the former. Although this week's lesson is taken from the latter Scripture, both themes are present in the material chosen for study.

**Divine plan and purpose (51:4-8)**

The basic passage (49:1-52:12) opens with the second servant poem (49:1-6) in which the servant of the Lord speaks to the nations, telling them God chose him for a larger task than merely restoring greatness to Israel. He is to be a messenger of salvation to the world.

The symphonic drama continues, however, with words of consolation as the prophet announces Israel's speedy return to Jerusalem and the rebuilding of her waste places. This line of thought continues through 51:3, with various promises and exhortations from the prophet as he speaks for God to Israel, assuring her of God's concern for the nation's future.

Beginning with 51:4, however, God makes clear His purpose to extend His righteousness and salvation to the entire world, not merely Israel. Having given words of comfort (51:1-3) to Israel, the prophet seeks to enlarge her horizon by pointing that God's instruction, justice, and salvation will be a light to the entire world.

The nations will seek guidance from God, and the righteous will be assured of His everlasting favor, Isaiah reported. This promise was designed to provide the faithful of Israel with moral courage and strength to withstand the taunts and abuse of ungodly people who were causing them frustration and misery.

Although elements of the universe should dissolve, the Lord's salvation will endure. The whole visible creation, heavens above and earth beneath, are transitory, but the precepts of the Lord, as well as His grace, will never be destroyed. What a message of comfort to Israel!

What did these verses mean to Israel and what do they mean to us?

To the people who were captives in Babylon, the prophet's message served as a source of strength for their difficult days. Unfortunately, however, they too often interpreted the prophetic encouragements with a nationalistic thrust rather than in a spiritual sense as God in-

tended. This attitude presented a great problem when he sought to present God's Kingdom as the rule of the Lord in the hearts of men rather than political freedom for the Jews from Roman bondage.

The spreading of God's righteousness and salvation to the nations is fulfilled in the preaching of the gospel to the Gentiles. The true Jew is not physical Israel but spiritual Israel, and true circumcision is of the heart, not the flesh (Romans 2:28, 29).

God chose Israel to be a blessing to the world, and the return from Babylonian captivity was but a further step toward bringing God's eternal purpose to fruition and reality. Any evangelization of the world must work within the framework of understanding the true nature, purpose, and "plan of God for the ages."

**Good news! Let everyone rejoice!**

(52:7-10)

A lyrical outburst concludes this larger section. The prophet sees the exiles returning to Jerusalem under God's leadership, heralded by messengers who announce the good news that the city has been redeemed.

The power and salvation residing in the Lord guarantees peace. A general feeling of exultation pervades the entire section.

The main thrust of the passage is that God has shown to Israel and to the world that He reigns and will never abdicate His position nor will He forfeit His authority to anyone.

Those who guard the city now understand clearly the eternal purpose of God and are ready to join the others in praising His name. They see the worldwide

plan in God's redemptive program.

Paul picked up this beautiful thought and applied it to those who proclaim the message of Jesus Christ (Romans 10:15).

The ultimate fulfillment of this passage, and others like it, is found in the final outcome of God's insistence on righteousness for the nations. "Baring His arm," God entered the arena of conflict to produce this righteousness by sending His Son to be a "Suffering Servant" for sin, the theme we will study in next week's lesson.







# Anderson urges Baptists to face family crises

NASHVILLE (BP)— The crises confronting families in America today are also problems that threaten Southern Baptist churches and the denomination as a whole, warns Douglas Anderson, secretary of the Baptist Sunday School Board's family ministry department.

Citing the skyrocketing divorce rate and numbers of parents rearing children alone, Anderson said, "I think it can be documented that what is occurring nationwide is occurring at almost the same rate in our churches."

Other family-related problems Anderson listed included difficulties among blended families of remarried persons, grandparents separated geographically and by divorce from their grandchildren, and low self-esteem of persons attempting to rebuild their lives from broken relationships.

"The consequences of what has been happening the last five to 10 years will be with us the rest of this century," he noted.

Anderson believes pastors and other church leaders sincerely want to help family members in crises, but many simply do not know what to do or how to do it.

"At best we know how to preach at them but not how to help them change their attitudes and behavior," he said. "The problems are too large and too complex for simplistic or authoritative approaches. The crisis is real, nationwide, and not a church is untouched by the problems and needs of families."

On the other hand, he praised churches which are providing ministries to mem-

bers and non-members in counseling, marriage, and parenting enrichment and which are emphasizing the importance of family Bible study and worship in the homes.

Christian Home Week, scheduled this week (May 1-8) in many churches, is one way to emphasize the value of homes where God is the first priority, Anderson

said. The 1983 Christian Home Week theme is "Family: Opening the Word Together."

Christian Home Week is also the only event a church must put on its calendar to be part of the 1982-85 Strengthen Families emphasis. Other facets of the emphasis are implemented through Sunday School, church training, pastoral

and deacon ministries, music, and media libraries.

If ways are not found in churches to help families, Anderson said the crisis threatens to severely weaken Bold Mission Thrust efforts to share the gospel with the entire world by the year 2000.

On the one hand, Anderson said, "If we don't articulate the difference the gospel makes in our homes, non-Christians can legitimately question what the gospel offers. If we're not able to point to people with changed lives, we're going to have difficulty."

On the other hand, the breakup of Christian families is affecting key leadership in churches, including the clergy, deacons, and Sunday School teachers. For example, he said the rate of divorce among ministers appears to be approaching the rate of the general population.

"Where is the people power for Bold Mission Thrust if the energy of our leaders is sapped at the point of their most intimate relationships?" asked Anderson.

As to solutions, Anderson urges church leaders to give priority to enrichment for healthy families and ministry for those in need.

"We need to remember Jesus Christ came to us in the arms of a family," he said. "We are called to make disciples and to help people integrate the gospel into meaningful human behavior. This is where we're not doing our job."

In helping people who are hurting from broken relationships, Anderson said, "we must come to grips with our task as a people who redeem and who reconcile."

## Church chooses relocation from suburbs to inner city

PHOENIX, Ariz. (BP)— While some churches flee the downtown area, a Phoenix church has opted to move into the heart of the inner city.

Given the opportunity and funds to move almost anywhere, members of Parkview Baptist Church recognized their church's responsibility to minister to the less fortunate of society. Instead of moving to the suburbs, the church moved further downtown.

As early as 1965 some recommended the church, in the airport relocation area southwest of Sky Harbor International Airport, disband or move. It was slated to relocate in 1975 and last January the city finally bought the church property for \$960,000.

According to James Hiatt, pastor of the church, Parkview would have been

all alone within a year as the city continued to buy the houses around it.

Along with the relocation came a name change. In order to avoid barriers erected by the word "Baptist" and thus be able to better minister in its new community, Parkview changed its name to The Church On Fillmore SBC.

The facilities, which originally housed the First Church of God, were sold to a Christian social organization about a year ago. A member of that organization approached the Baptist Foundation of Arizona about buying the property as an investment.

Parkview bought the First Church of God facilities for \$363,000 and then spent additional funds to buy adjacent property.

Why would a church that has operated on a shoestring budget for 18 years opt to

remain in the inner city when it has the money needed to move into the suburbs?

Hiatt's motivation for ministry goes back to his childhood when "I was always from the wrong side of the tracks. I understand the feelings of the people in these situations."

Hiatt sees a big vacuum in Christian ministry in the middle of town, and he and the church are challenged by that fact. Church members have ministry opportunities now they never had at Parkview, said Bill Crofts, president of the Arizona Baptist Foundation. "The church can be a wonderful neighborhood focal point," he added.

The Church on Fillmore plans to be an inner-city church that cares for people and is involved in the lives of people. Some of its ministries will be outside the traditional ministries of the church. "If we have to do things that are not normal," Hiatt said, "we will do them to meet the total needs of the people."

The church hopes to build a retirement complex of 35 apartments and have at least some of them operational within six months. Members also hope to have a boarding home open within the next year.

Already some in the neighborhood have responded to the presence of their newest resident, and church members have not even started visitation. On March 13, the second Sunday at the new location, with 86 in Sunday School, attendance was up 20-25 over the average attendance at the old location.

With its 28,000-square-foot, debt-free facility, the possibilities for growth are unlimited, Hiatt said.

One area that probably really will grow in the church's new location is its

Spanish work, with Alejo Maldonado as pastor. The church has an integrated Sunday School and separate worship services at the same time in different parts of the building.

Parkview was started as a mission of First Southern, Phoenix, in 1938. As one of the oldest Southern Baptist churches in the city, it has been dramatic for the church to move and change names. Hiatt said, adding that members are adjusting to the change very well.

Like their pastor who, as a student at Grand Canyon College, "happened to go down and fill in once and has been there ever since," the members of The Church on Fillmore have accepted the challenge of ministry in the inner city.

## Puryear pastor takes Cross Roads pulpit

Hervy D. Hudson accepted a recent call to the pastorate of Cross Roads Baptist Church, Bells.

Hudson came to the church from Puryear Baptist Church, Puryear, where he was also pastor. His previous pastorates include First Baptist Church, Maury City; East Baptist Church, Paducah, Ky.; and Bardwell Baptist Church, Bardwell, Ky. He has served as moderator of several associations, as a member of the Tennessee Baptist Convention Executive Board, and as preacher of the convention sermon at the 1979 TBC meeting.

The Haywood County native is a graduate of Union University, Jackson, and New Orleans (La.) Baptist Theological Seminary.

## William Jewell aids Taiwan effort

LIBERTY, Mo. (BP)— William Jewell College has established a program of "Bold Mission Scholarships" for Taiwanese Baptists.

The full-tuition scholarship has a value of more than \$15,000 over a four-year degree program. It is available to nationals who are members of Taiwanese Baptist churches and who meet William Jewell admissions standards, including the ability to do academic work in English.

The scholarship program, according to President Gordon Kingsley, is an effort to conserve, extend, and expand the work done by Missouri Baptists over a three-year Bold Mission Taiwan project.

"Baptists have always depended on education to solidify and advance the gains of evangelism," said Kingsley. "We want to educate leaders who will return to their churches and communities in Taiwan and carry forward the witness of the gospel."

In 1981, Kingsley and five other representatives of the college went to Taiwan to preach, lead conference sessions, teach Bible, and conduct youth camps.

The college also took the lead in forming a prayer chain to provide support for Missouri Baptists ministering in Taiwan. Two students will be working on the island in two months as summer missionaries.
